

Describe Circumstances of the Accident

Travelling along Lentor Avenue from Yishun to SLE.

Accident occurred somewhere in the middle of the distance from the junction of Yishun Ave 1 → SLE.

There was a road works in the center lane of the Lentor Ave and only lane 1 and 3 was available

At the sight of roadworks, I drive in the lane 3, along the kerb and reservoir side, going straight.

One of the vehicle, GBL4667M, made the decision to filter out of the blocked lane and the accident happened.

His back wheels area and my right front bumper made contact and I was forced into the end against the kerb, also damaging my left front wheels and rims.

We stopped along the road to exchange particulars
