

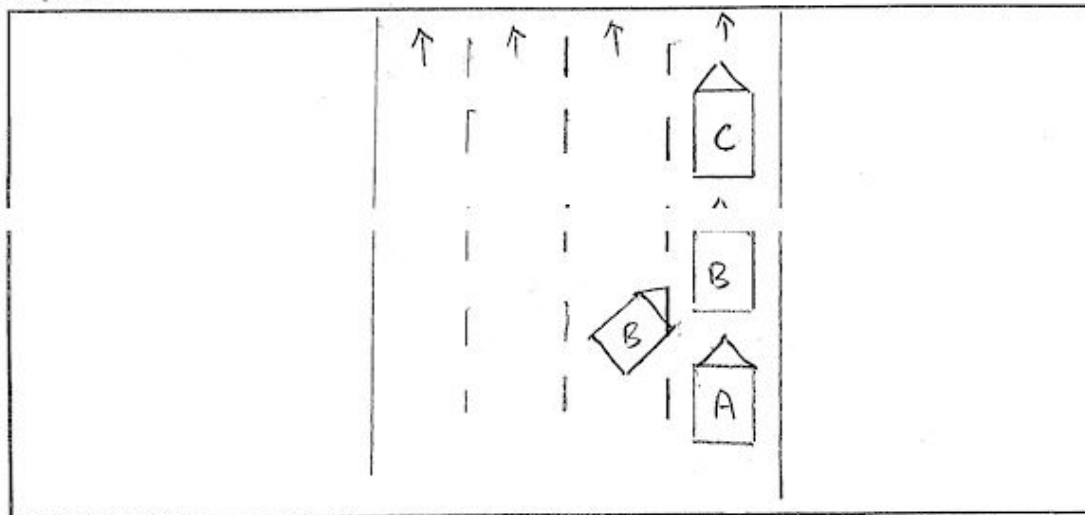
SKETCH PLAN

Initially shocked and thought that the last car is always at fault, I told my wife my speed could be fast and I could be distracted. However, when I exited the car, the driver and passenger of car B confronted car C. I learnt from them that car C has jammed brake when there was no need to. Car B has to also jammed brake.
