Brief Details.

On the above mentioned date, time and location, I was riding my bike (JPX5898) along Orchard Turn, near to Wisma Shopping mall. The weather was slightly drizzling and floor was wet. It was a two way road and I was travelling straight ahead. Suddenly there was a black color vehicle (looks like Toyota Alphard or Vellfire), travelling from the opposite direction and turning right turn into the drop off point of Takashimaya. This resulted in me colliding into the left side of the vehicle. I flew from my bike and over his vehicle and landed on the other side of the car.

Someone approached me and told me to not move and just rest there and wait for ambulance to arrive. Soon later, the traffic police and ambulance came and I was conveyed to the hospital shortly. On the same day, I received a WhatsApp whom informed that he is the driver involved in the accident. His contact number is 80282692. The doctor diagnosed me with my right lower limb shin puncture wound with hematoma and I had a surgery done. I was also given 19 days MC from 06/03/2022 to 24/03/2022.

I do not have the vehicle details as well as the driver details as I was in too much pain to move during the accident.

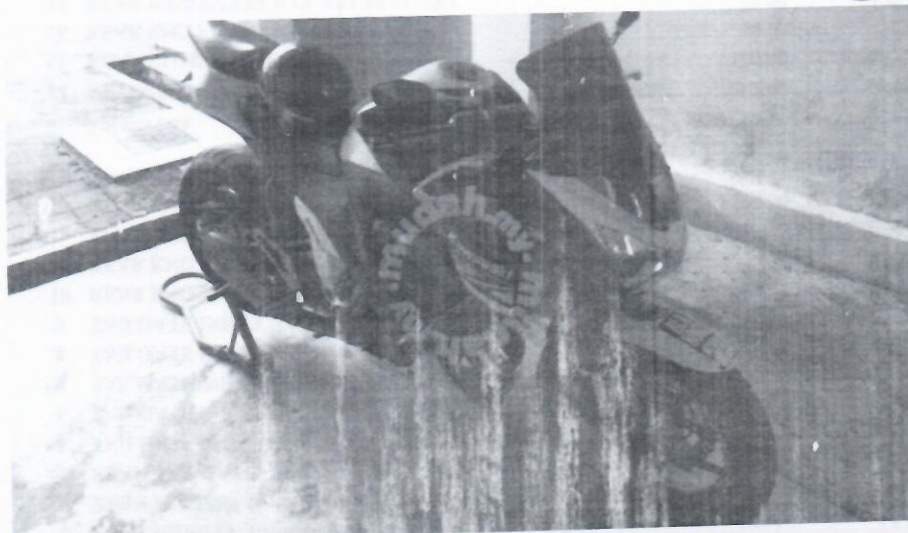
