#### CIRCUMSTANCES OF ACCIDENT

THE ROAD CONDITIONS WERE WET AND RAINY. AFTER TURNING AT A ROUNDABOUT TO GO DOWN TO THE BASEMENT CAR PARK ON A SLOPE, A VEHICLE NEGLIGENTLY AND RECKLESSLY DROVE INTO MY LANE WHILST I WAS EXECUTING THE TURN. I HAD VERY LITTLE TIMES TO REACT TO THE VEHICLE AS I WAS JUST NEGOTIATING THE TURN AND THE SLOPE HAD A SHARP TURN. THE VEHICLE WAS RIGHT IN MY LANE AND HER CAR SWIPED MY RIGHT BUMPER WHICH RESULTED IN SUBSTANTIAL DAMAGE. THE LADY DROVE UP THE SLOPE FOLLOWING THE IMPACT WHERE I HAD STOPPED COMPLETELY. AS SHOWN IN MY PHOTOGRAPH MY VEHICLE WAS WELL WITHIN MY LANE. THE LADY ADMITTED LIABILITY AND OFFERED \$300 AS FULL AND FINAL SETTLEMENT. I MENTIONED THAT I HAD TO REPORT THE ACCIDENT AND CONDUCTED A DETAIL SURVEY OF THE DAMAGE TO THE VEHICLE.

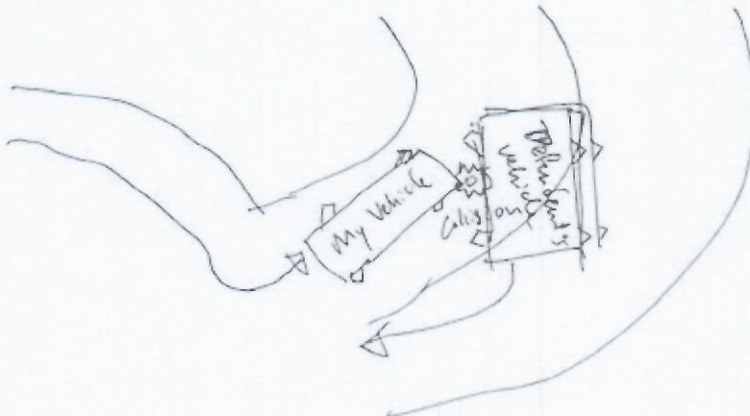

## Describe Circumstances of the Accident

The road conditions were wet and rainy. After turning at a roundabout to go down to the basement carpark on a slope, a vehicle negligently and recklessly drove into my lane whilst I was executing the turn. I had very little time to react to the vehicle as I was just negotiating the turn and the slope had a sharp turn. The vehicle was right in my lane and her car swept my right bumper which resulted in substantial damage. The lady drove up the slope following the impact whereas I had stopped completely. As shown in my photograph my vehicle was well within my lane. The lady admitted liability and offered \$5500 as full and final settlement. I mentioned that I had to report the accident and conducted a detail survey of the damage to my vehicle.
