**ACCIDENT INVOLVING SMT 1534K & SLQ 8341G AT OR ALONG AYE ON OR ABOUT
19 NOVEMBER 2021**

We act for Yang Kun ("our client"), the owner / driver of SMT 1534K involved in the above-captioned accident.

On or about 19 November 2021, at or along AYE, there was an accident involving SMT 1534K and SLQ 8341G. It is noted that the driver of SLQ 8341G had negligently driven and/or managed SLQ 8341G, thereby causing the accident between SMT 1534K and SLQ 8341G.

We note that India International Insurance Pte Ltd were the insurers, Grab Rentals Pte Ltd were the owners and Ho Hai Min was the driver of SLQ 8341G at the material time of the accident.

On the issue of liability, please find enclosed the following documents: -

- a. GIA Report / Singapore Accident Statement of Yang Kun, the driver of SMT 1534K, dated 19 November 2021 of three (3) pages, together with sketch plan of one (1) page, handwritten statement of one (1) page and photographs showing the damages to SMT 1534K of ten (10) pages; and

On the issue of quantum, please find enclosed the following documents: -

- a. Letter of Authority signed by our client dated 19 November 2021 of one (1) page;
- b. Notification of Accident from JP Conceptz Pte Ltd dated 22 November 2021 of one (1) page;
- c. Satisfactory Voucher from JP Conceptz Pte Ltd dated 26 November 2021 of one (1) page;
- d. Vehicle Inspection Report from Pro Plus Automobile Engineers dated 4 December 2021 of five (5) pages together with inspection photographs of twenty (20) pages;
- e. Invoice from Pro Plus Automobile Engineers dated 4 December 2021 for the sum of \$979.00 of one (1) page; and
- f. Proforma Invoice from JP Conceptz Pte Ltd dated 13 December 2021 for the sum of \$6,534.97 of one (1) page.

As a result of the aforesaid negligence, our client has suffered the following losses: -

(a)	Costs of repairs (including GST):	\$6,527.00
(b)	Loss of use (from 22 November 2021 to 26 November 2021) (Based on \$120.00 per day for five (5) days including GST)	\$642.00
(c)	Survey report fees:	\$979.00
(d)	LTA / GIA search / report fees:	\$36.49
(e)	Legal costs / disbursements contribution at this stage:	\$700.00

Any settlement reached in this claim is on the basis that it does not prejudice any other relevant action that may arise out of this accident, in particular, the uninsured losses claim, if any.

We hereby give India International Insurance Pte Ltd as insurers of SLQ 8341G notice that if the above is not acceptable, our client intends to proceed to issue a Writ of Summons against your insured. In this regard, please give us an acknowledgement of receipt and also let us know if you are instructing a firm of solicitors to accept Service of process on behalf of your insured within fourteen (14) days of your receipt of this letter, failing which our client will have no alternative but to commence proceedings against you without further notice.

For Grab Rentals Pte Ltd, please let us know within the next **seven (7) days** if you are taking the position that Ho Hai Min was not your authorised driver / servant / agent of SLQ 8341G at the material time of the accident. If we do not hear from you within the next **seven (7) days** and in any event by **17 March 2022**, we will proceed on the basis that Ho Hai Min was your authorised driver / servant / agent without
