



My airbags were not deployed despite the massive impact and as my body lurched forward only to be restrained by the seat belt, I knocked my knee against the underside of the dashboard.

I alighted to realise that I was involved in a 4 car chain collision involving:

- SME7027Y
- SMF2583K
- SMC4137T
- SLP4385L

where I was the 3rd vehicle.

The front portion of SLP4385L, which was the last car in the chain accident, was badly smashed and its airbags were deployed.

There was another separate accident between 2 vehicles behind SLP4385L.

Initially, I only felt pain over my knee which I had knocked.

However, the same evening, I started feeling aches over my neck, shoulders, lower back and left ribcage areas.


