We are instructed by the above named to claim damages against you/your insured in connection with a road traffic accident ALONG AYE (TUAS) BEFORE CLEMENTI ROAD EXIT LANE 2 involving our client's vehicle registration number FBC 3822 K and vehicle registration number SHD 6584 B driven by your insured/you at the material time.
- 3. We are instructed that the accident was caused by your insured's/your negligence in the driving and/or management of your insured's/your vehicle. ## 9. Please note that this letter of demand is made without prejudice to our client's right to claim for personal injury damages arising out of the same accident.
