

CONTINUATION OF REPORT

Brief Details.

On the 7th of July 2016, at around 2107hrs, I was driving along Loyang Avenue in my blue Mercedes Benz bearing registration no.:SDE2200C. I was travelling on the most left of a 3-laned road. Beside my car in the middle lane was a 5-ton army truck bearing registration no.:MID21238. As we approached a red light, all vehicles came to a stop. As the traffic light turned green, the army truck beside my car suddenly moved towards my car and then swiped it leaving scratches on my car.
