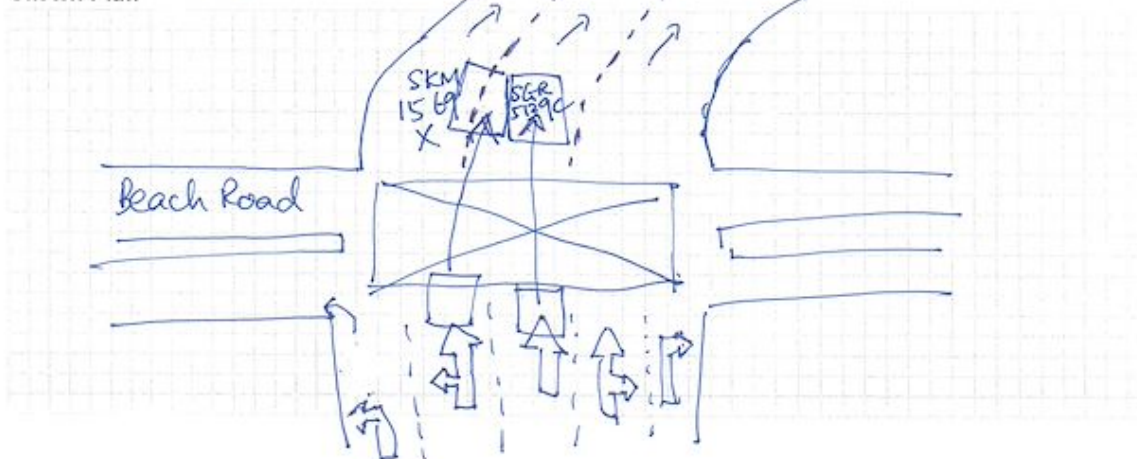

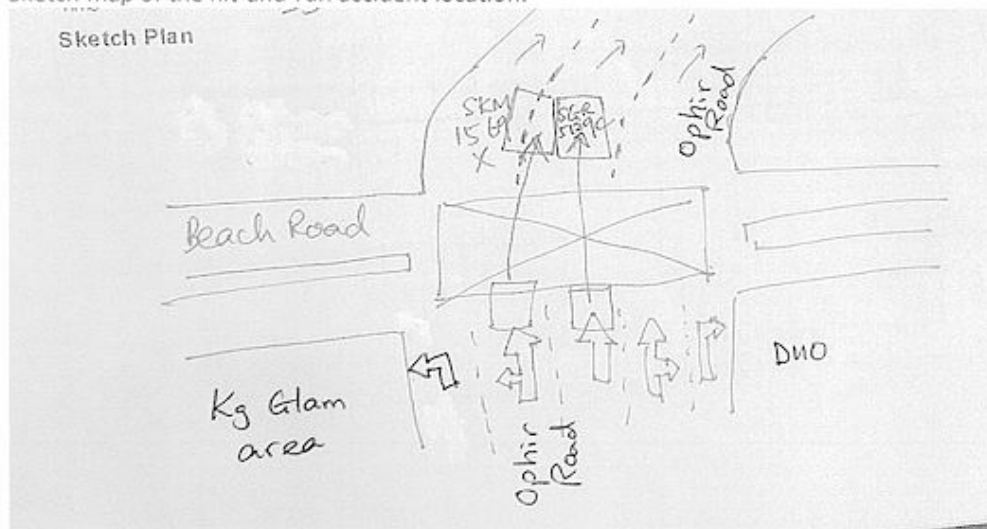

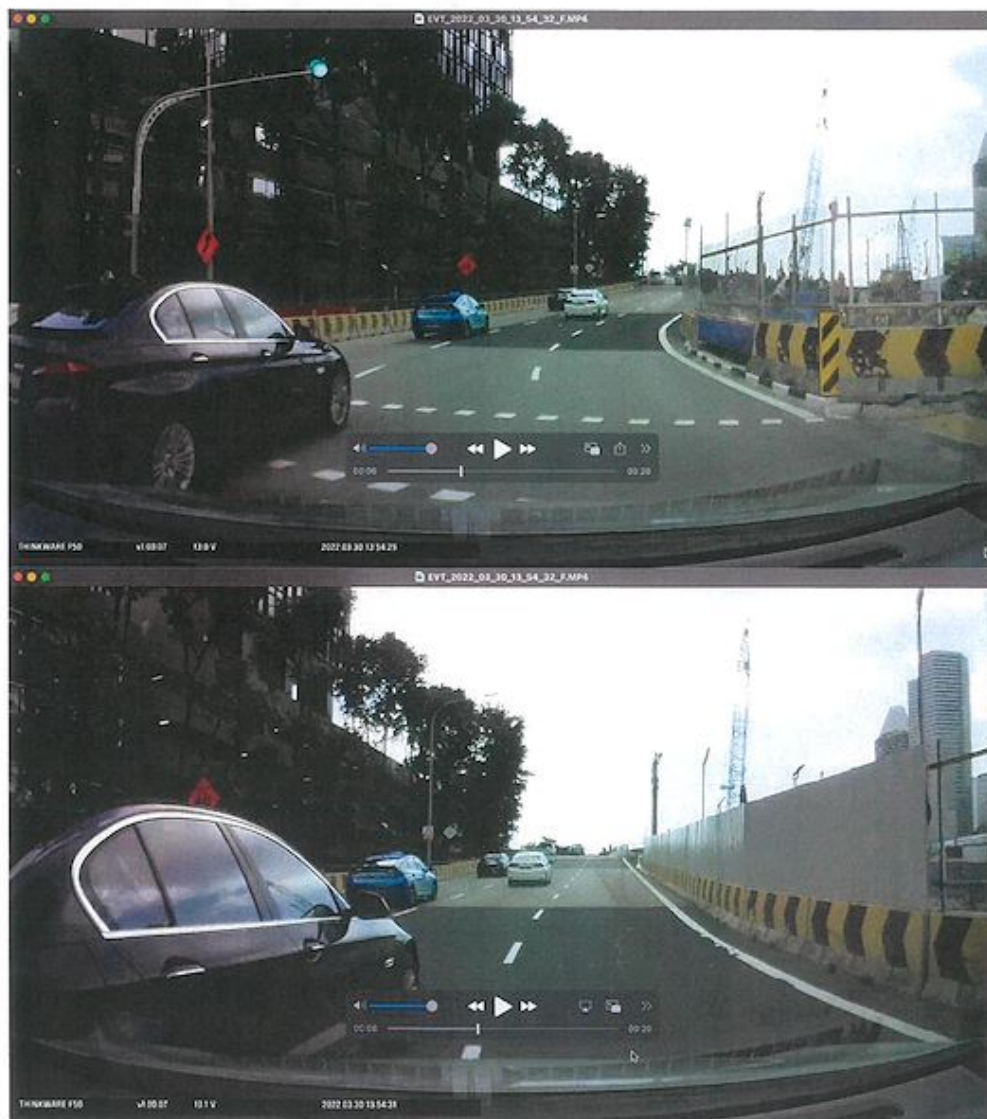

Brief Details.

At about 2:31pm on 30th March, I was in the middle lane on the 5-lane junction of Ophir Road with Beach Road (with Duo Residences on my right and Haji Lane to my left). I started driving forward when the traffic lights turned green and followed the dotted lane markings on the yellow box into the middle lane of Ophir Road (with Pan Pacific Serviced Suited Beach Road on my left). The dark-coloured car SKM1569X (BMW?) on my left started drifting into my lane as I finished crossing the yellow box junction (see pdf file attached). The driver did not signal right and gave me a shock, so I quickly sounded my horn whilst I moved into the lane on my right to avoid it. SKM1569X side-swiped the left, front side of my car and kept moving forward (see map on pdf). It was too dangerous to stop there, so I drove carefully across Ophir Road and turned left into Republic Boulevard to stop and examine the damage. The other car did not stop.

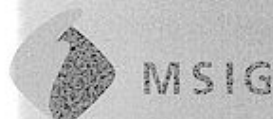
