On 25.03.2022 I was riding my motorbike FBP3186U along Peterson Road towards Scotts Road. When I was reaching the junction of Paterson Road and Orchard Boulevard, green light were in my favour therefore I proceeded straight.

While crossing the junction suddenly a car from the opposite side without any signal or warning made a right turn towards Orchard Boulevard. Upon seeing it I tried to stop but could not stop in time and hit onto the left centre side of the car.

I fell off from my motorbike.

I was conveyed by ambulance to Tan Tock Seng Hospital and was admitted from 25.03.2022 till 30.03.2022. I was given 15 days of hospitalization leave.

I sustained fracture of my left hand.
