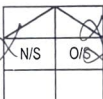

Brief Details.

On the above mentioned date, time and said location, I was riding my Malaysia motorbike, Yamaha JTN7027, red in colour at the right lane along Alps Avenue towards N Perimeter Rd. When I was on the right lane proceeding straight which opposite ongoing lane is the Bus stop(DHL) number 95179, suddenly one white in colour SUBARU car SLE677D which is on my left lane made a sudden U turn without signalling and as I want to avoid collision, my bike then swerve to the right ongoing lane and eventually collide onto the SUBARU car right front portion. I then fell onto the ground and lye flat. There are 2 pass by then shift me to the side and call for police and ambulance. After the collision, I immediately felt pain on the whole of my left leg and also suffer abrasion on my left hand area. After about 20 min later, police and ambulance arrive and I was conveyed straight to Changi General Hospital. The doctor then inform me that I suffer fracture from my left butt area all the way to left thigh. Both my eye was also swollen and red. I was admitted and warded on 5/3/2022 until 30/3/2022 and was given 26 days mc which also the period from on 5/3/2022 until 30/3/2022. I wish to state I am the only one injured and due to the accident my motorbike damages is the front and right portion.

There is one witness that saw the whole accident and his detail is Hassan HP: 84391541.
