SKETCH PLAN



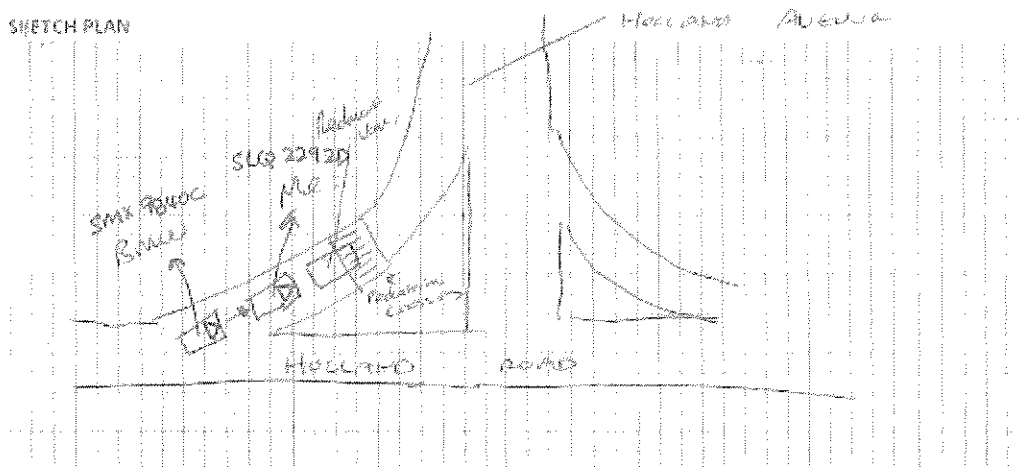
