

**RECORD OF ACCIDENT ON 2 MARCH 2022 INVOLVING SDV 2833L**

On Saturday March 2, 2022 at 12.17pm, my car SDV 2833L was involved in an accident at the junction of Orchard Road and Scotts Roads. My car was in the third lane from the left while the other accident vehicle, a silver Porsche Cayman was in the second lane from the left. Both vehicles were waiting at the traffic light to make a left turn.

As evident from the rear view camera(of my car) video clip, the Porsche took a bigger turn while turning left, veered to the right and hit the left rear wheel of my car with the right corner of the front bumper. As I did not initially realize that there was a collision, both the vehicles only stop to survey the damage when the other driver, a middle aged Chinese lady signaled to me to stop further down Scotts Road in the direction of Newton Circus. No injury was sustained by either parties.

Unfortunately I did not record the car registration number of the Porsche.

Since there is no significant damage to my car, I am just filing for record.

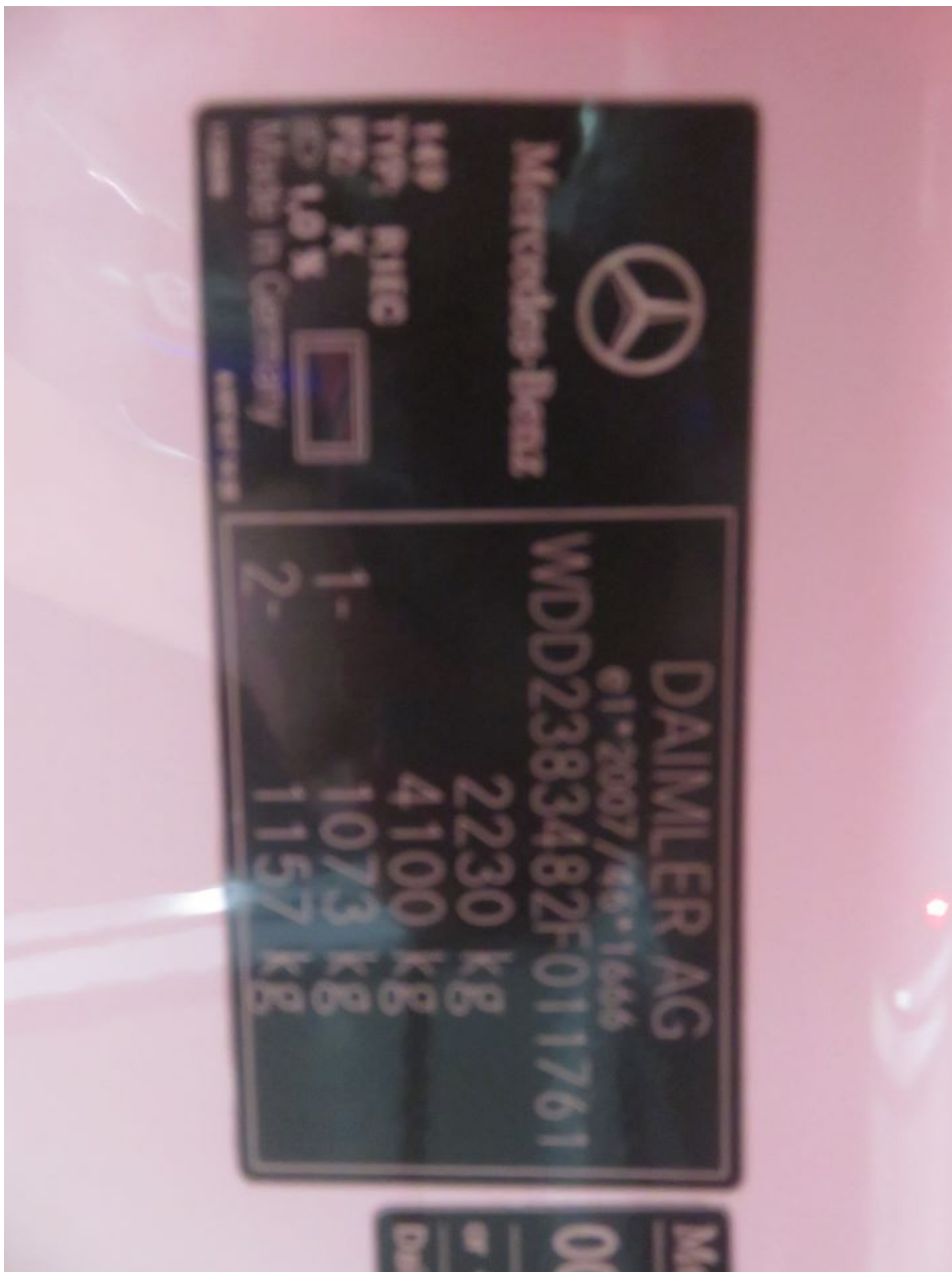

And provided further that the Motor Vehicle is registered under the Road Traffic Act (Chapter 276) and its registration under the Road Traffic Act (Chapter 276) has not been cancelled at the time of the accident, loss or damage.

#### Limitations As To Use

Use only for social, domestic and pleasure purpose and for the Insured's business. The Policy does not cover use for hire or reward, racing, pace-making, speed testing, reliability trial, the carriage of goods other than samples in connection with any trade or business or use for any purposes in connection with the Motor Trade.

#### ExcelDrive Workshops and Accident Reporting
