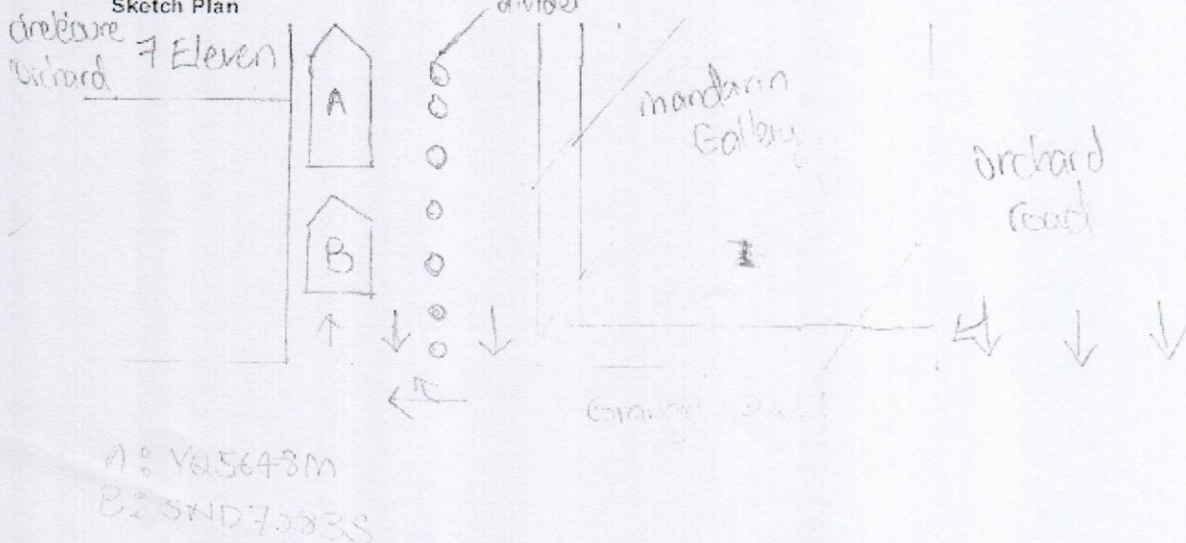

Describe Circumstances of the Accident

(SND72835)

13th April 2022 At 05:46 am I stopped my car about 5-6 metres behind (YQ5648M) a Mitsubishi Fuso truck who had stopped outside the 7 Eleven also. My intention was to quickly buy a coffee before going to work. I left my car in parking and as soon as I left about 40 seconds later, the truck reversed into my car. I came out of the 7 Eleven and the driver had moved his truck behind my car. He approached me and apologised saying he had reversed into my car and said that he did not check and it was his mistake. We exchanged particulars after I checked to see what was the damage. My front bonnet (bumper) was dented and the grill had broken in. He also took pictures of the damage to my car and the license plate (front & back) of his truck. No one was injured and we both left the scene after taking each other's particulars. I later checked my dash cam footage to confirm the events above and they were accurate. I then proceeded to file this report at 08:41 am at Comfort Delgro (Spark car care) at Braddell road.
