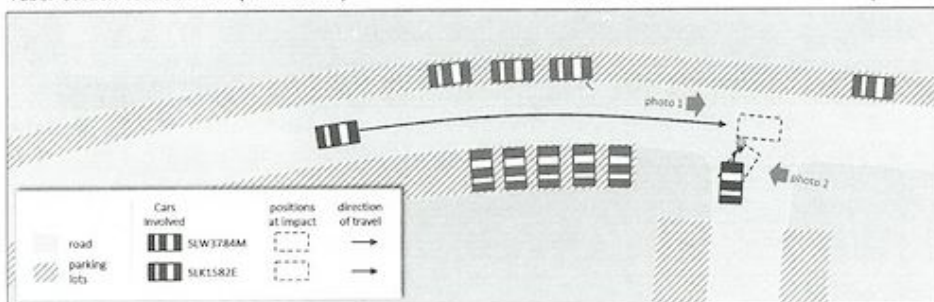

Accident Description

Accident on internal access roads of Faber Garden Condominium (near Block 6)

time: ~0900

date: 09 April 2022



I was driving my car, dark blue Audi A3 SLW3784, and stopped at a T-junction of the internal access roads, coming from Block 6, about to turn right onto another internal access road of Faber Garden Condominium (see above diagram). After glancing left to make sure there was no oncoming traffic from the left, I started to turn right slowly onto the other access road.

Suddenly I saw a red Toyota Altis SLK1582E flash in front of my car and felt my car shake.

Both cars stopped soon after and both drivers got out.

The right side of her car (SLK1582E) just before and after her right rear wheel had been scratched. The left front of my car (SLW3784M) had been scratched including the bumper and the left headlight. See section on Photographs for more details.

0945 11 Apr 2022

The driver of the red Toyota Altis SLK1582E, Noreen Chua (S0112929E), said that she had not seen my car and that she was in a hurry.

I told her that if she had been slower, the front of her car would have hit my car on the left side; as it was her car was fast enough to *almost* gone completely past my car.
