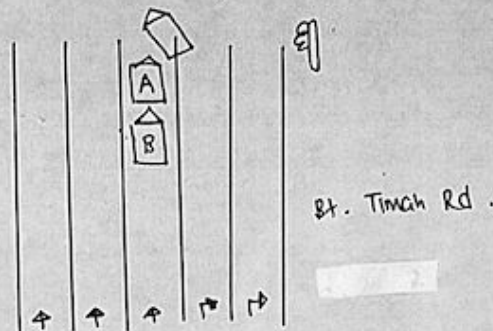

B= SJM2387J

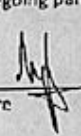


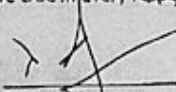
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

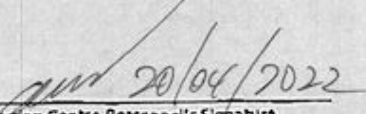
