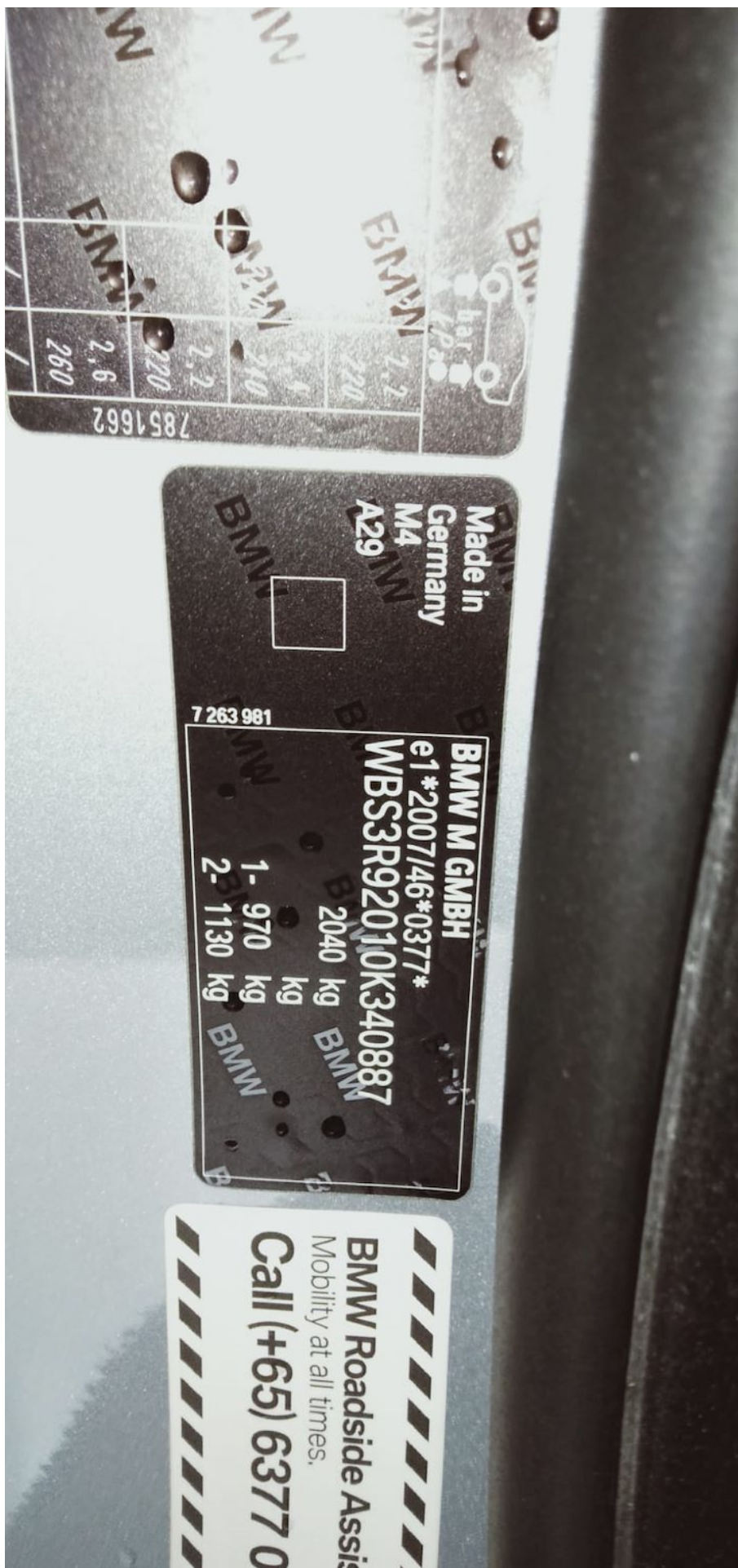

Brief details.

I was driving my vehicle (SCR6500D - BMW M4) travelling along North-South highway returning back to Singapore from Malaysia. Accident occurred approximately 38km marker, 4km before Hentian Sebelah Kulai South Bound RNR stop. Weather is clear, road are slight damp and sky is dark from approaching rain. From about 40km/hr, I managed to come to a complete stop as the vehicle at the front have stopped. Around 2 sec later, I look at my rear mirror and saw a Singapore registered car approaching and crashed into my rear along with 2 other vehicles at the back. I went down the vehicle immediately to

check for any injuries or damages to the vehicle. Upon confirming that everyone is fine and no one is injured, I took photos of the accident scene and proceed to the road shoulder to not block up the high way.

I am the first car and the car behind me is SMG6158Z (Feroz) followed by SLD8470K(Cyrene) and the last vehicle is SKR505K(Hector).

All the vehicle is able to be driven back to Singapore except for the Mazda 3 (SLD8470K) which have to be towed back. We proceed to the RNR stop to exchange particulars and also called up our Insurer for advice. As there were no injuries, damages to public property and no foreign vehicles involved, we were told it is not necessary to report to the Malaysia or Singapore police. It was on agreement that we need not involve the police.

However, later at night the driver of SLD8470K - Cyrene, sent a whatsapp message that she have reported to the JPJ about the accident and warned us to return back to Skudai Police Station to file a report within 24 hours or our vehicle will be detained when we enter Malaysia border later. I will be sending my vehicle to reporting centre and I am not comfortable to drive my damaged vehicle back to Malaysia to file an accident report.

I have dash cam footage in my vehicle to show the accident.

As such, I will be providing this police report I make to my insurer and also relevant authority in Malaysia in the future if I got detained.
