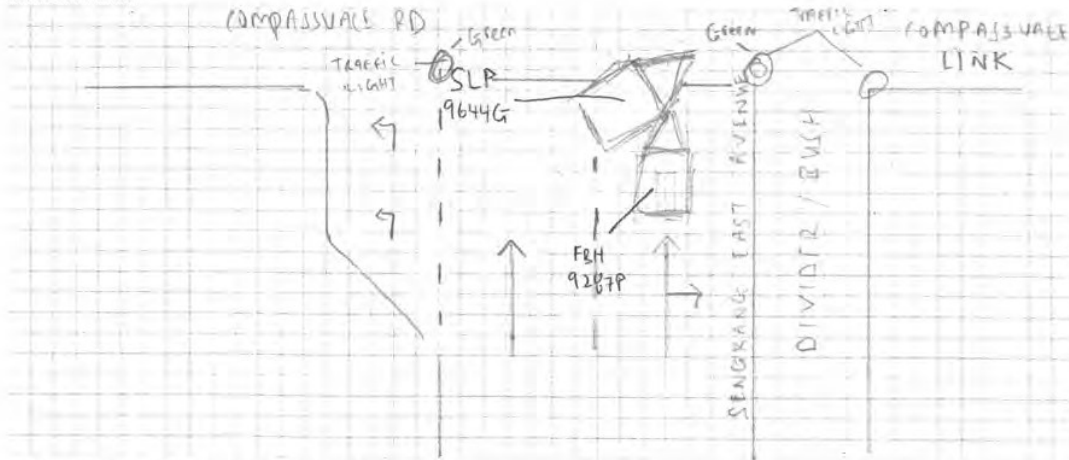

**SKETCH PLAN**





**DESCRIBE CIRCUMSTANCES OF THE ACCIDENT**


I was riding along SeangKang East Avenue, towards Punggol Road, while approaching junction of Compassvale Link and Compassvale Rd, at the very last arrow of the junction, a blue Honda Freed, bearing number SLP 9644G, change lane abruptly from lane 2, which is going straight only. I was at the first lane, near to the car. I tried to swerve and jammed my brakes but unfortunately, we collided. I managed to jump off my bike, before my bike got stuck. I was blessed as I was riding slow, within the road speed limit. After which, she came out off the car and apologised to me. She admitted it was her fault and kept saying that she was following the GPS, asking her to Uturn. She claimed she cannot see me but I explained to her that does not give her the right to Uturn from the second lane. There is no Uturn sign along the junction. I hit her right driver door. When I was assessing myself for injuries, she moved the car and I told her off that she should not as we need to take pictures but it was too late and she claimed that she was do not know what to do. The traffic light was green during the accident.
