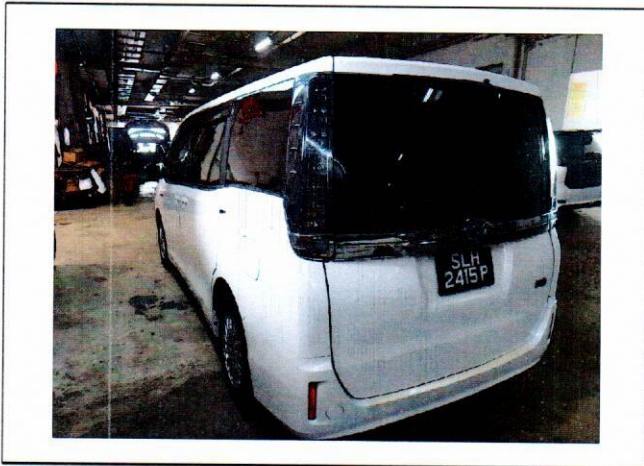

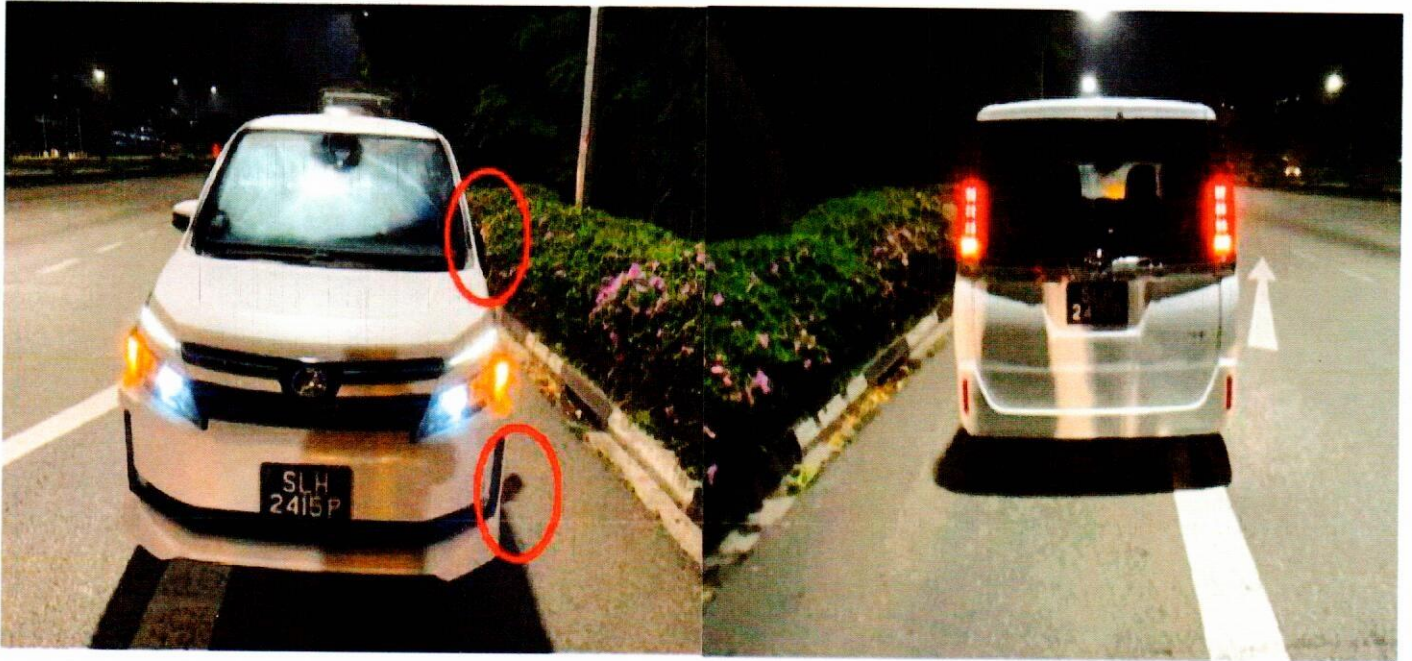

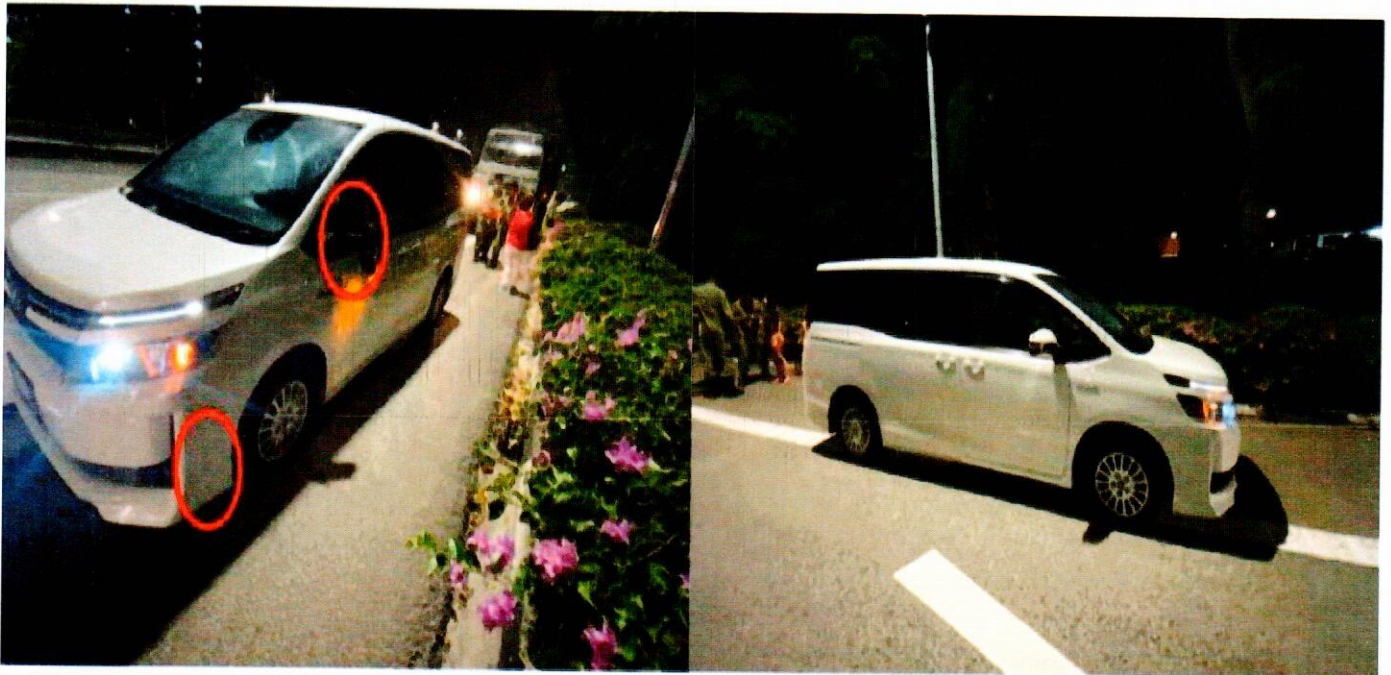


Front View of SLH2415P

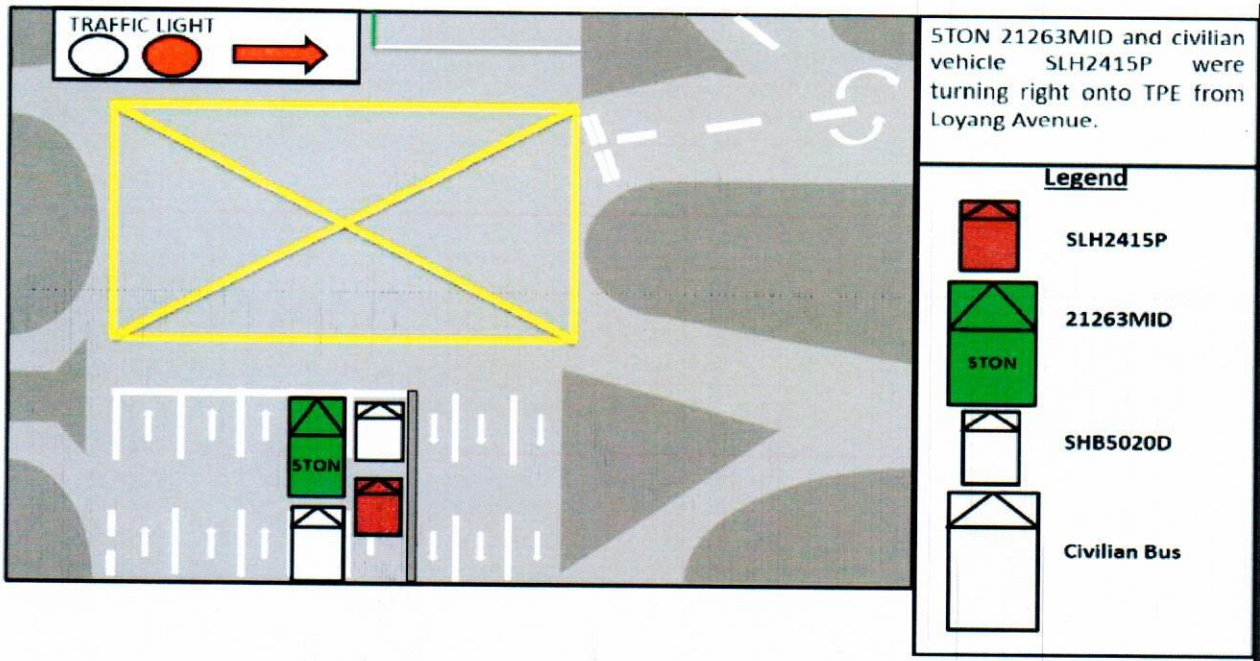


Figure 2A: Schematic Diagram Pt. 1

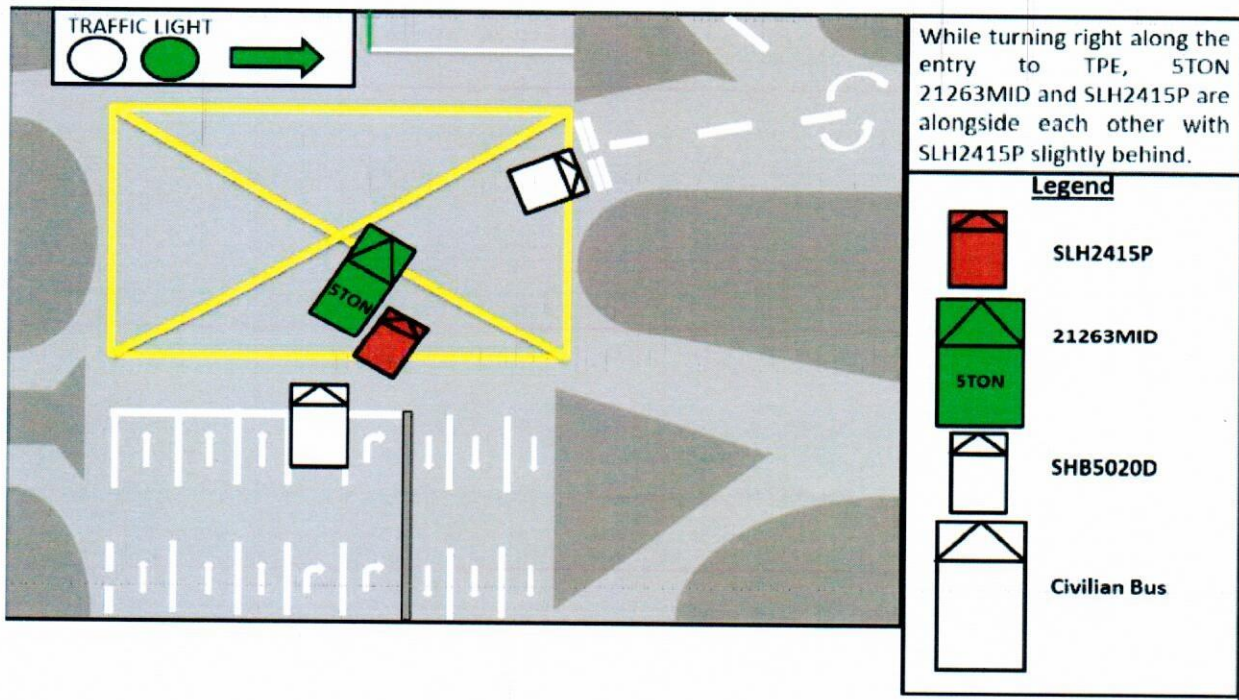


Figure 2B: Schematic Diagram Pt. 2

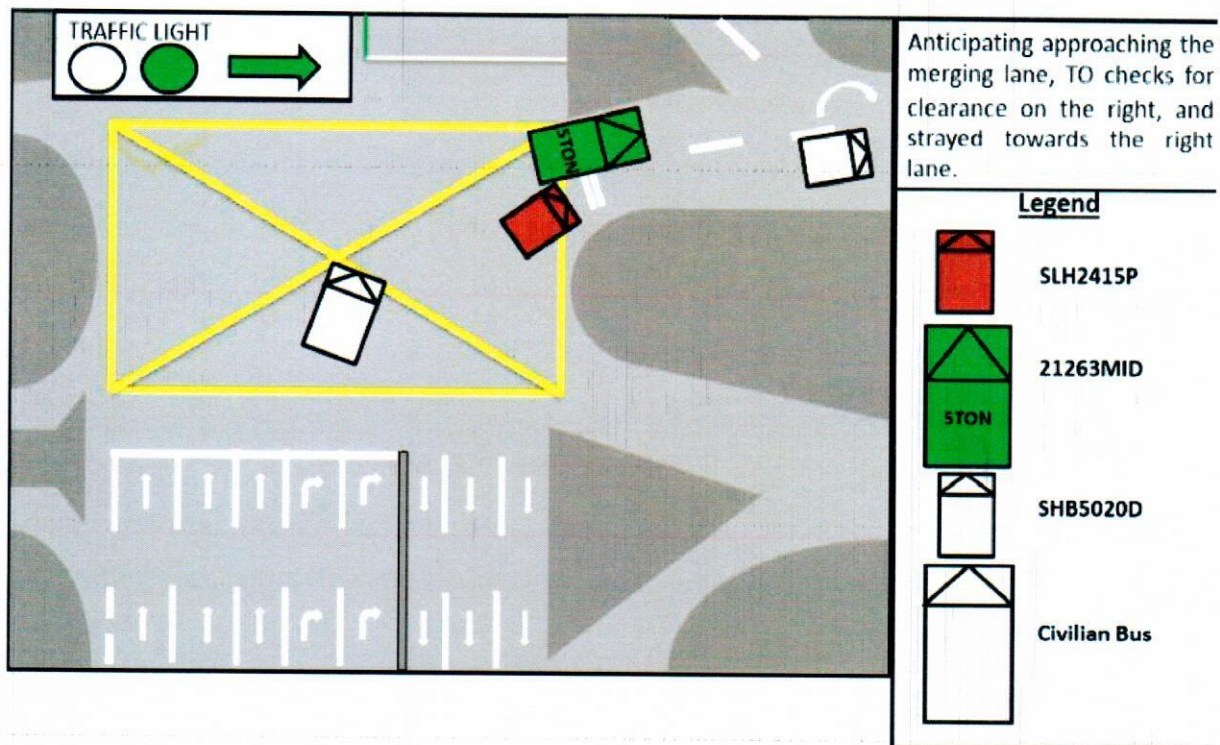


Figure 2C: Schematic Diagram Pt. 3

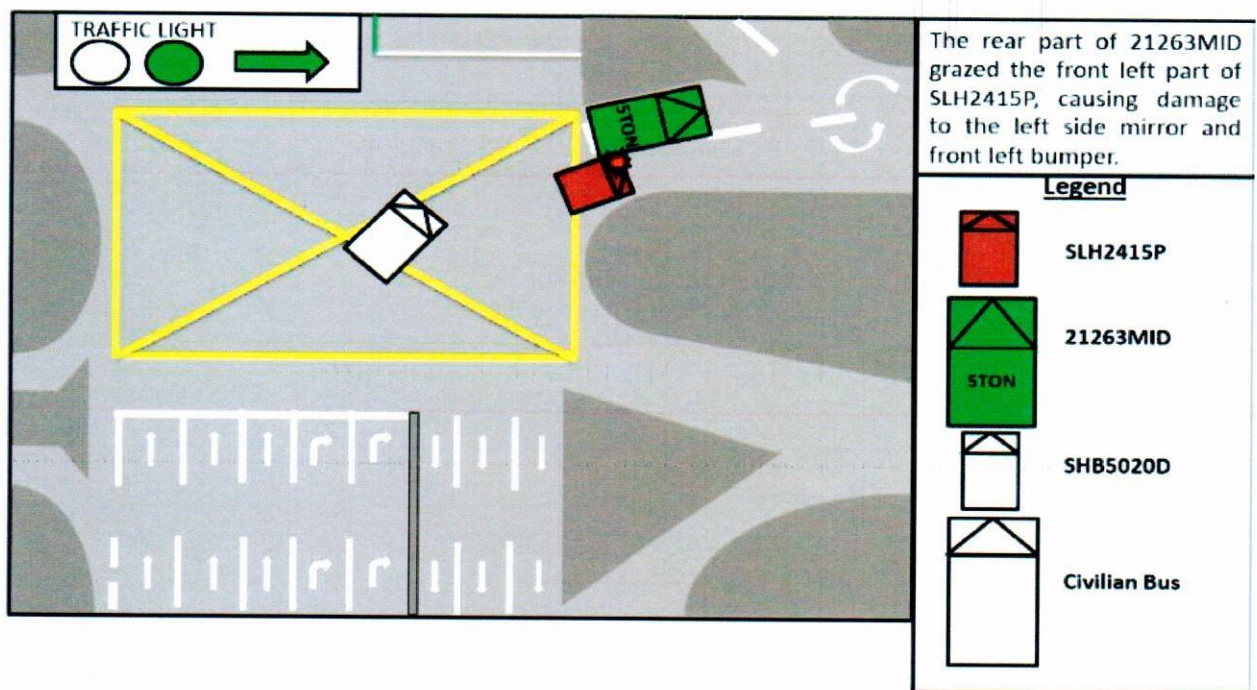


Figure 2D: Schematic Diagram Pt. 4

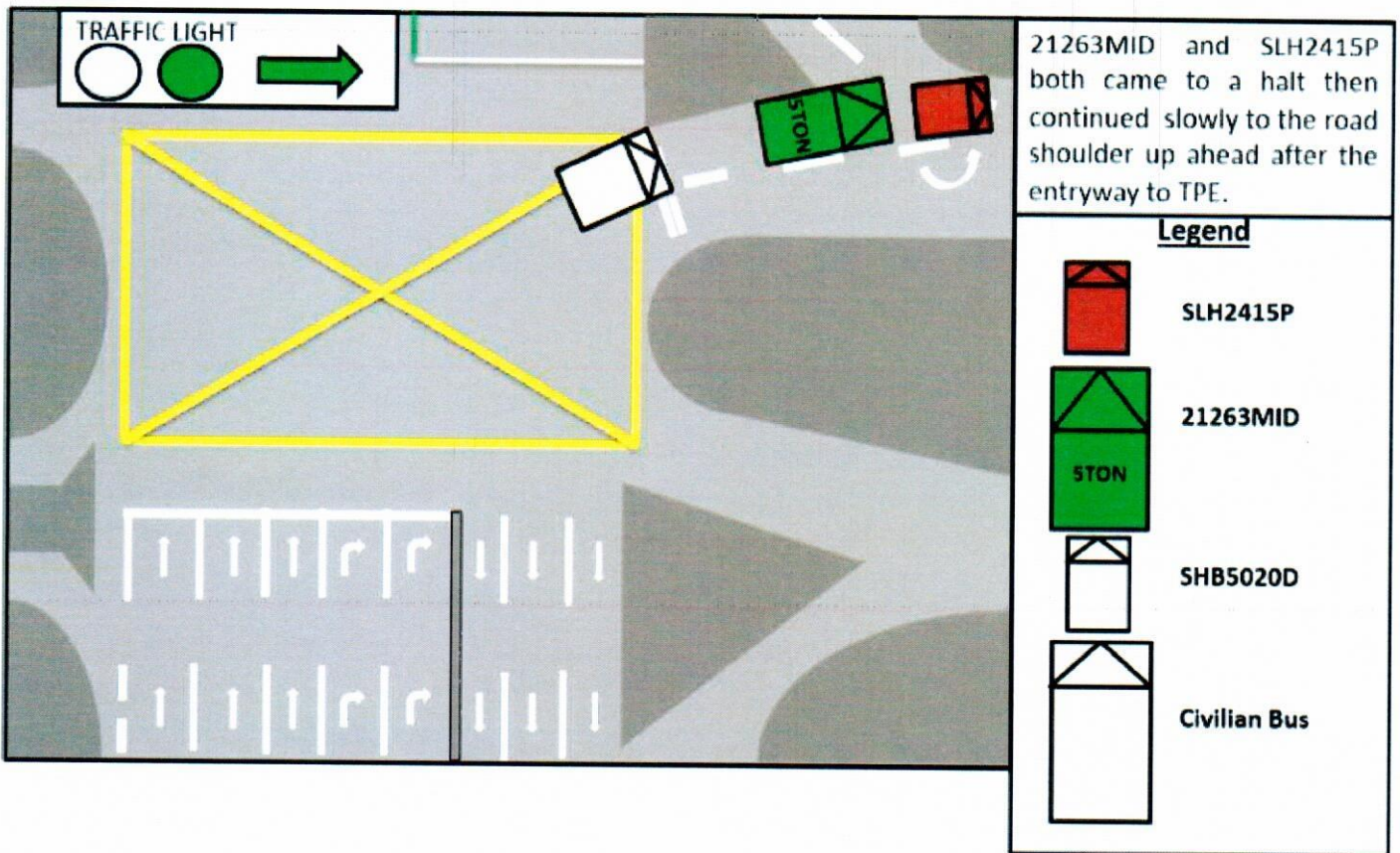


Figure 2E: Schematic Diagram Pt. 5
