

Keeping this on record.

Yesterday, Motor Image workshop was asking me about the payment arrangement for collection of my car on Monday (18/7/2022), I was a little confused and upon further clarification with them, they said that this is a cash repair, not a repair under insurance claim, so either I pay them directly to collect the car myself, or get the insurance to pay them and I collect the car from Insurance.

I contacted LKK Auto, and Steve told me that the repair went well, but LKK Auto do not handle the payment. Tried contacting Toplis (Victor) after that, but to no avail.

I have spoken with Gennal (Mr. Pang) since, and he had emailed Toplis about the matter yesterday.

Mr. Pang and I have spoken again this morning, but there is still no response from Toplis. I have pointed out to Mr. Pang that we should get this resolved urgently because there are logistical arrangements to extend my season parking for the replacement car if there is a delay in collection, and if I am still able to collect on Monday, I also need to arrange for the car rental company to pick up the rental car, but right now, I am clueless what to do next.

Mr. Pang advised me not to worry because the payment should be between the workshop and the insurance company, and in the event there is a delay that incurs extra charges from extension of car rental or storage charges from the workshop, their insurance should be covering. Nonetheless, I would still <u>need a confirmation whether I can make the necessary arrangements for Monday to collect the car, and there will not be any payment issues with the workshop.</u>

In addition to the above, I am also waiting for confirmation from Toplis per my email on 5/7/2022 regarding the paint protection coating and reimbursement for the car rental.



I am requesting the Authorization form from Motor Image.

There are 2 outstanding items which are not yet resolved.

- 1. Paint protection coating. I discussed with the surveyor (Steve), and he requested that I forward the receipt for the original coating, and advised that I get a fresh quotation and then send that to him for confirmation to proceed. Upon completion of the coating work, send the receipt. For this, I need to get a clear confirmation whether I can proceed as there will be cash outlay on my end until reimbursement (not clear whom is fronting this). Also, do take note that the coating cannot start work until 7 days after a fresh coat of paint. I will get the quotation this weekend as I am currently quite busy with work, in the meantime, appreciate if you can follow up with the next step and a confirmation whether I can proceed with this item after Motor Image has completed their work.
- 2. **Loss of use**. According to the surveyor, the repair by Motor Image will take 15 days (even though Motor Image stated 15-16 working days). There are some issues here:

Motor Image do not handle car rental, hence, I will need to find my replacement car outside. The adjuster mentioned that if he can't advise if Motor Image don't handle this item.

I need clear instruction on the reimbursement regarding the car rental, and I won't be able to proceed with Motor Image if there is no replacement car during the period of the repair

In the event there is a delay from Motor Image, Example 1: Let's say Motor Image revert on the 15th day that they can only complete the work on the 16th work day, adjuster had mentioned that it's going to take 15 work days, how should we handle the loss of use for the 1 day of delay from the

workshop? Example 2: Motor Image completed the work ontime, but when I collect the car, there are issues with the repair work, and needs rectification work, which could take another 2-3 days, how should we handle the loss of use for the 2-3 days of delay?


