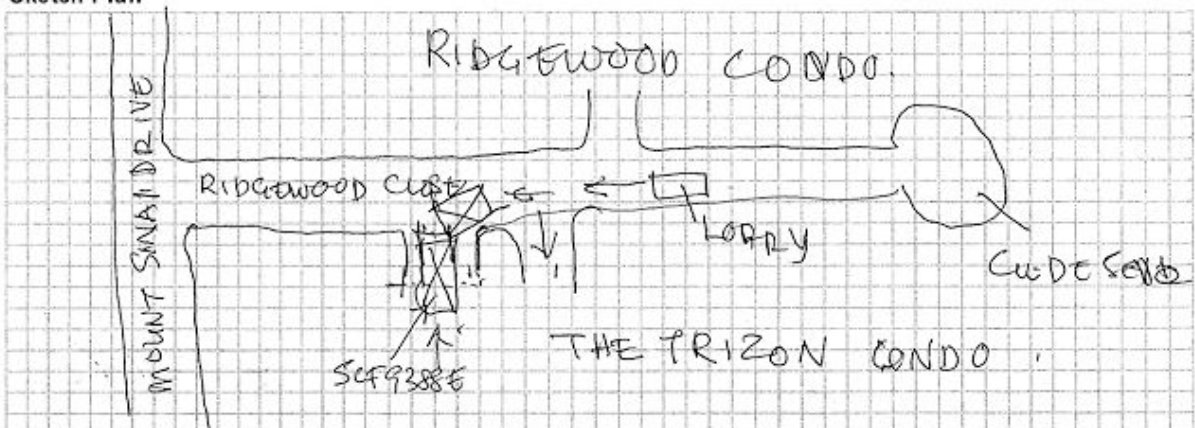

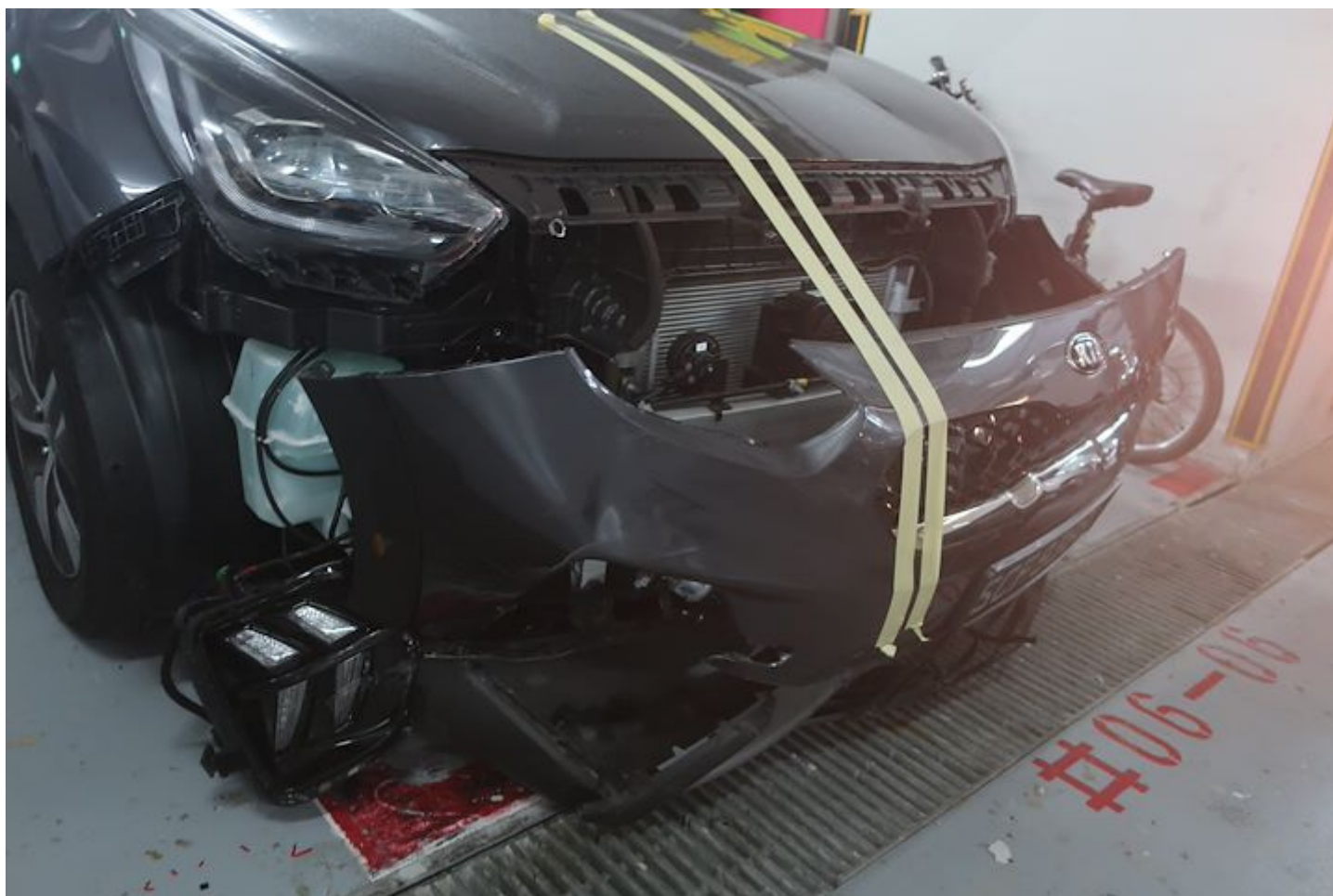

**Brief details.**

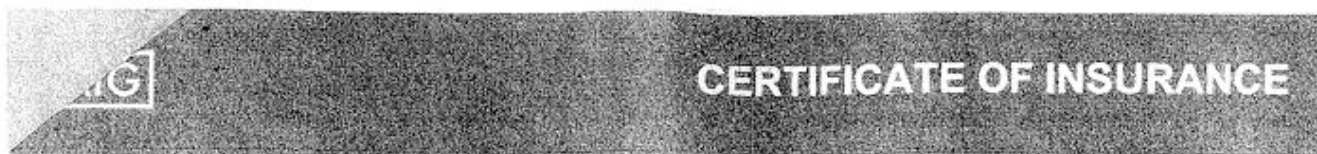
