We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, China Taiping Insurance (Singapore) Pte Ltd to deal with the third party claim against your policy.

We have received a claim from SHC7637K against your motor insurance policy.

We have informed him that third party has submitted a copy of video footage to show that he reversed and slightly hit onto third party taxi front right side. Our driver noted that there is evidence to prove and agreed on collision. Our driver also confirmed that the accident was happened on Thursday(21/04/2022) instead of Friday(22/04/2022). We have send him an addendum form to amend the DOA. Our driver may consider to private settle if the amount is acceptable. We will update him again once we received LOD from third party.
