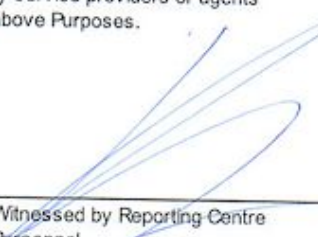

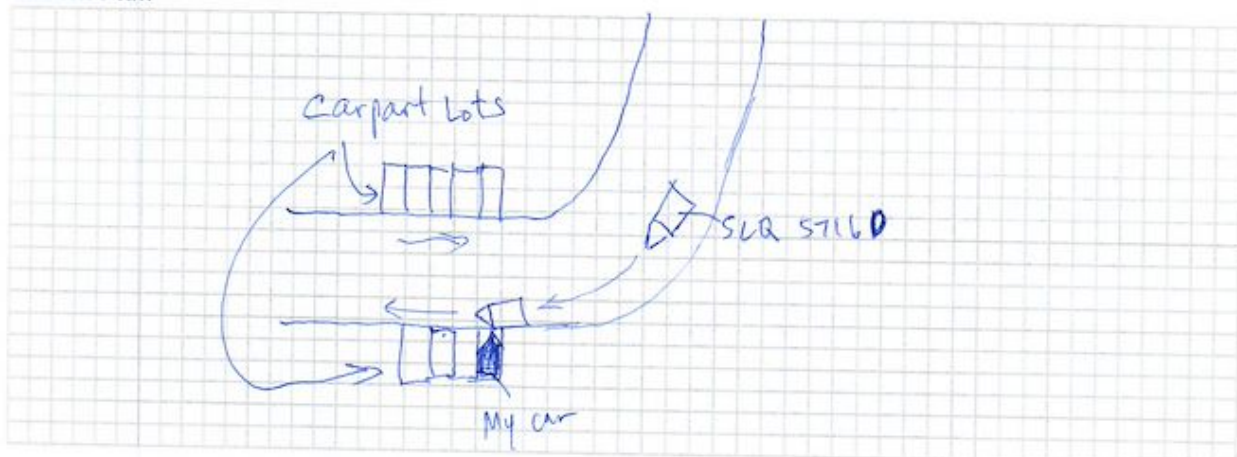

There were two persons ran to me and asked me to come down to check my vehicle.

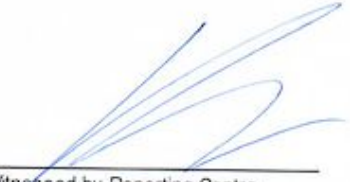
