

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.


We have received a claim from SLQ5716D against your insurance policy.

Based on all available information on hand, we are of the view that we do not have a good defense towards the claim submitted by third party (SLQ5716D). Attached here with a copy of video from car camera of SLQ5716D for your easy reference. We have extracted video screenshot as below for your understanding. We observe that the position of your vehicle was within the parking lot before third party pass by your vehicle. After third party drove pass, there is slight jerk on his vehicle. From the rear view of camera, we observe that your vehicle already out of the parking lot. In view of this, we are of the view that your vehicle had moved forward and collided with third party who was passing by your vehicle.

Furthermore, the damages sustained to third party vehicle was on left rear side and your vehicle damages was on front portion. The damage profile to both vehicles suggested that third party had already driven pass and hit by your vehicle.
