WHILE TURNING RIGHT, SUDDENLY ONE M/LORRY (GBK365R) CAME FROM MY REAR AT THE SECOND RIGHT LANE AT A FAST SPEED ALSO MAKING A RIGHT TURN TO MAXWELL ROAD AND ENCROACHED INTO MY PATH AND THUS COLLIDED ONTO THE FRONT LEFT PORTION OF MY VEHICLE.

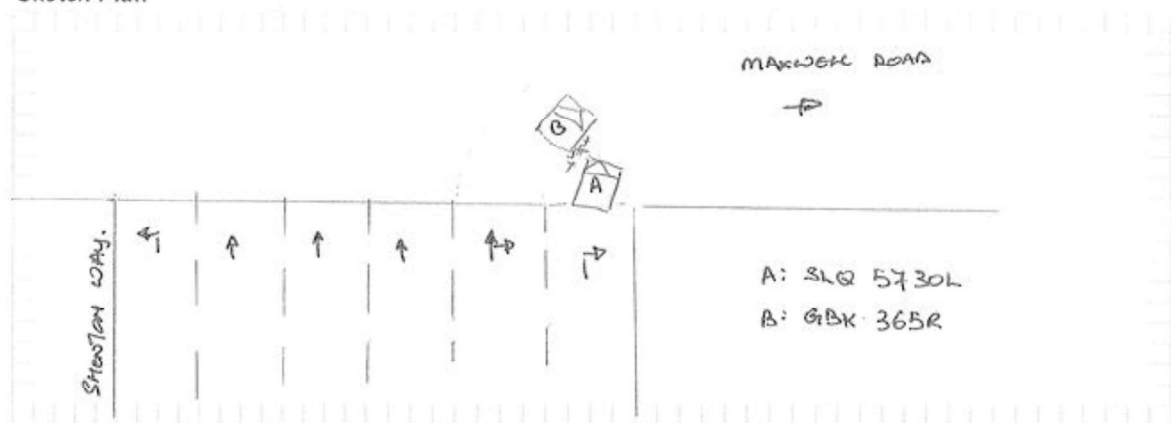

I WAS TRAVELLING ALONG SHENTON WAY ON THE RIGHT MOST LANE OF 6 LANES, I WANTED TO MAKE A RIGHT TURN TO MAXWELL ROAD. WHEN I STOP AT THE JUNCTION DUE TO TRAFFIC RED LIGHT, WHEN THE TRAFFIC LIGHT TURNED GREEN, I PROCEED TO MAKE MY RIGHT TURN TO MAXWELL ROAD, WHILE TURNING RIGHT, SUDDENLY ONE M/LORRY GSK 365R CAME FROM MY REAR AT THE SECOND RIGHT LANE AT A FAST SPEED ALSO MAKING A RIGHT TURNED TO MAXWELL ROAD AND ENCRDACHED INTO MY PATH AND THUS COLLIDED ONTO THE FRONT LEFT PORTION OF MY VEHICLE.

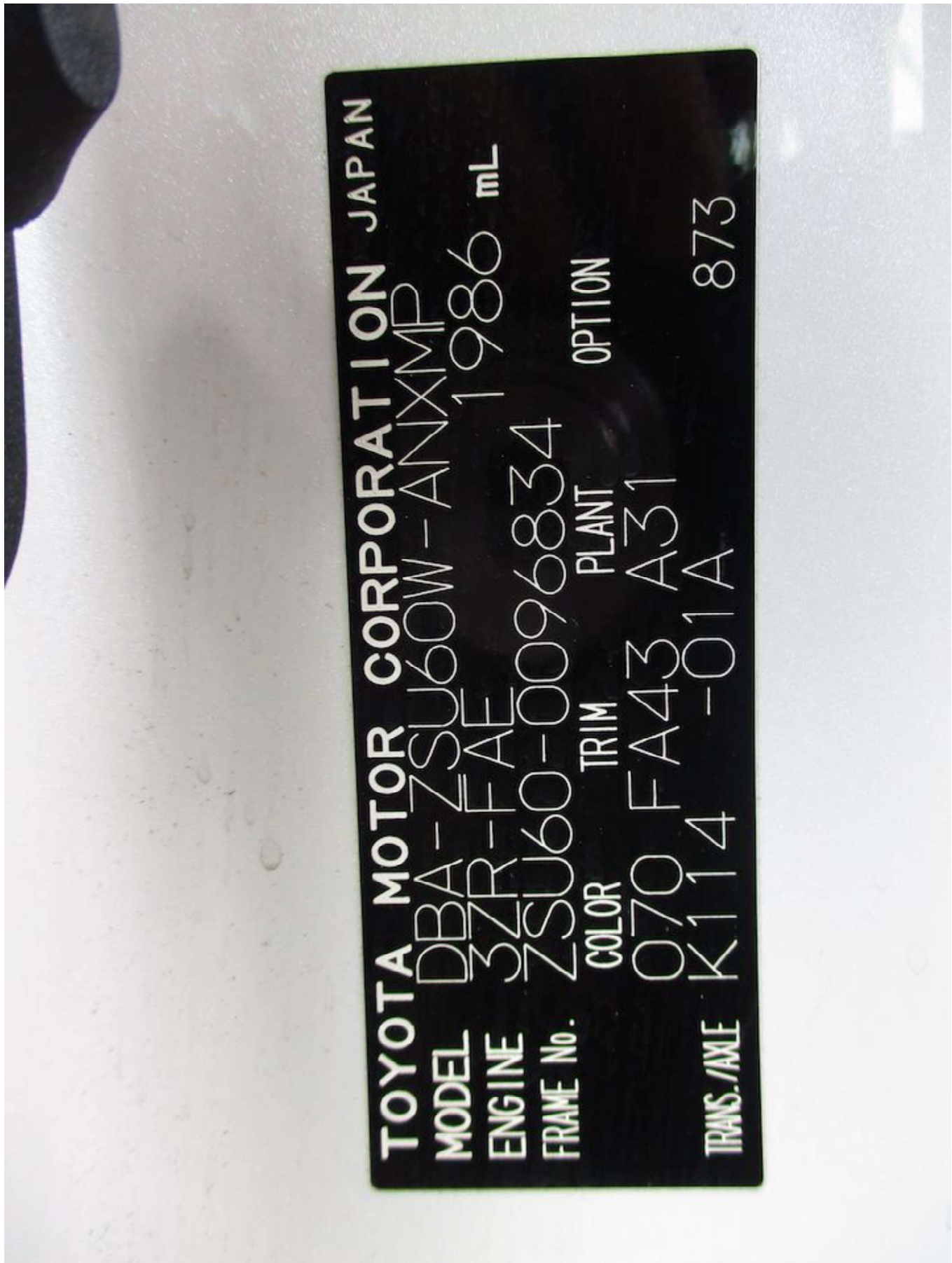
