


- (i) processing, handling and/or dealing with my claims including the settlement of the claims and any necessary investigations relating to the claims;

- (v) complying with applicable law in administering, processing, handling and/or dealing with my claims.



Vehicle B: SLX1702H




## Describe Circumstances of the Accident


