During our site inspection of the trailers on 25 May 2017, we were able to identify 1 out of the 7 trailers – Regn. No. TRD2851M - that is insured under item 68 of your Policy No. D-17086952MFVS, whose name plate was still intact. The other 6 trailers were entirely burnt; the registration plate numbers and ID tags on these 6 trailer chassis were destroyed by the fire, making identification literally impossible.
