



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 26/04/2022 @ 2000 hrs. I was driving on the right lane at about 50-60km/h. Suddenly car B, the taxi, drove out of the U-turn area, and about a quarter of his car length was in my lane. Then he braked. At the moment I saw him drove out, his car was already extremely near, about about 10m or less away, I braked immediately, but the stopping distance was too short. We collided, the collision was my right headlight area into his left headlight area.
