

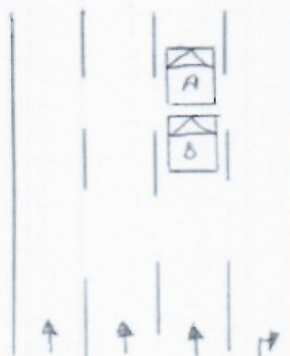
Sketch Plan
