Brief Details.

On the 28/04/2022 at about 1000hrs. I was driving my lorry (YP3896G) along Tuas West Road near Tuas West Road MRT station at the traffic junction. I was on the 2nd lane and was behind a prime mover with a trailer (XE4303P). The 3rd lane was blocked due to road works. Suddenly the prime mover made an abrupt emergency brake as a taxi had suddenly cut in front of him, this caused me to be unable to react in time and tried to manoeuvre my lorry to the left however was insufficient, resulting in the front right side of my lorry to crash into the back left side of the trailer. My lorry was totally damaged and had to be towed away while I suffered a talar fracture on my right leg and received 15 days hospitalisation leave. My passenger suffered some pains on his right leg and received 2 days MC. The prime mover's trailer only suffered minor damages to its left rear light and its driver was unharmed. I was conveyed to Ng Teng Fong General Hospital together with my passenger when ambulance arrived.
