

I, Tan Chin Poh (IC No S1484935A) am the owner and driver of a Mercedes Benz CLA 200 (Veh No SMQ8202M) and would like to file the following accident report, which took place at the basement 2 car park of Havelock II on 29 Apr 2022.

At around 4.10pm, I was inching my vehicle halfway out of a car park lot towards the left when a Mazda 5 (Veh No SKU 4054C), driven by Mr Jeffrey Wandly, suddenly cut into my path at speed from the south-easterly direction after rounding a bend, which resulted in a collision between the front right-side of my car and the front left-side of Mr Wandly's vehicle.

Not only did he not brake upon impact, Mr Wandly was going so fast that his Mazda ripped off the entire left section of my car's bumper before stopping a short distance away.

We then exited our vehicles and exchanged notes. According to My Wandly, there is a pillar at the bend in the car park that created a blind spot.

Points to consider:

- 1) By Mr Handly's own admission, there is a blind spot in the car park as vision is hindered by a pillar at the bend
- 2) My car park lot is not aligned to the adjacent lot but protrudes out in front, thus narrowing the pathway after the bend
- 3) My car's front grill was not damaged and the front bumper was also not dented in. Instead the bumper was ripped outwards from the left side, indicating that the impact was from a south-easterly direction
- 4) Mr Wandly was clearly speeding as evidenced by the substantial damage to my car's front bumper when it zipped across the front of my car.
