## Brief Details.

On 05/05/2022, I was driving my taxi (SHA7899C) along PIE towards Tuas on the left lane. I was queuing with the traffic to exit towards CTE Ang Mo Kio. At that time, I suddenly felt a collision from the rear of my taxi. I then went down my taxi to take a look and observed that one long (YP4023C) had collided to the rear of my vehicle.

I was informed that he was not able to stop in time and had collided to the rear of my vehicle. I then took photographs of my taxi and the lorry. I observed dents and scratches to the rear of my taxi. The rear boot is unable to close properly and the sensor light is damaged. I observed a dent on the front of the lorry. I had one passenger at that time and he left the scene by himself. The lorry had no passengers based on my observation.

We remained at the scene for about 10 to 15 mins before driving off. After driving off, I felt aches and pain at my neck, back, chest and shoulder area. I then drove to Mount Alvernia Hospital and sought medical assistance. I was then given 5 days MC from 05/05/2022 to 09/05/2022.

Hence, I am here to report this traffic accident. I will like to state that my taxi has the front and rear in car camera installed. However, I do not have access to the footages, if required.
