Brief Details.

On 19/04/2022 at about 1845hrs, I was riding my motorcycle bearing license plate no. FBH2609R along MacPherson road together with one Female pillion onboard with me. We were heading towards a T-Junction of Macpherson Road and Jalan Anggerek at said time. I wish to state that I was riding on the first lane at said time, on the said three-lane straight road. There was one motorcar bearing license plate no. SME3775Y on my left, driving on the second lane. While I was proceeding straight, the said vehicle on my left had abruptly made a U-turn. I wish to state that both the lanes that we were in was a straight-only road, thus the said driver was not allowed to crosscut and make a sudden U-turn from the second lane that he was in.

During said time, I had tried to slowly take over. I horned at him to make sure he is aware of me right before he made the illegal U-turn. I wish to state that I had no time to react due to his sudden movement, and thus we had collided causing an accident. I wish to state that the said junction had no U-turn sign as well, to allow the said driver to make the U-turn.

I wish to state that I had fallen to the ground together with my motorcycle and had lost consciousness. I had regained consciousness when I was already inside an ambulance which had conveyed me to Raffles Hospital.

On 20/04/2022 at about 0300hrs, an investigation officer had visited me in Raffles Hospital to enquire more in regards to the accident. I wish to state that I do not have any in-vehicle cameras installed however I had received footages of the accident forwarded to me by eyewitnesses during said time and had passed the footages to the IO. I had not assessed the damages to my vehicle, as I had gone unconscious at said time. I was also unable to take note of the driver's particulars and assessed his injuries and vehicle's damages. I also wish to state that I had lost my driving license and UOB bank card as my wallet had torn during the time of the accident.

I had received treatment in Raffles Hospital and National University Hospital and is currently planning surgery on my facial fractures of bones.

I had been contacted by SIO Abdillah from Traffic Police, who had provided me a case number reference to G/20220419/0183. My friend had also assisted me in lodging a police report reference to D/20220425/7017 which I had believed is inaccurate. Thus, I am lodging this vide traffic accident report

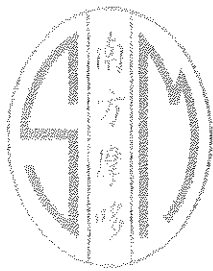
