**Describe Circumstances of the Accident**

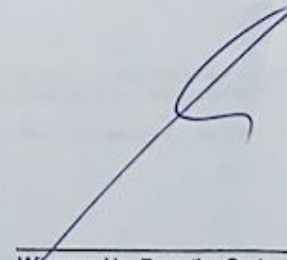
On 09/05/2022 at about 10:00AM. I was travelling along the
