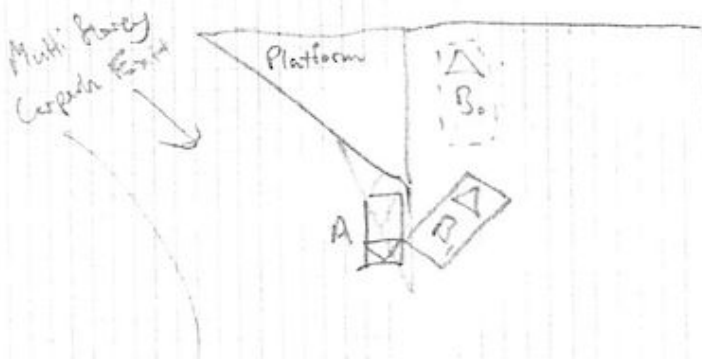

B: YP6505R


Describe Circumstances of the Accident


