SKETCH PLAN

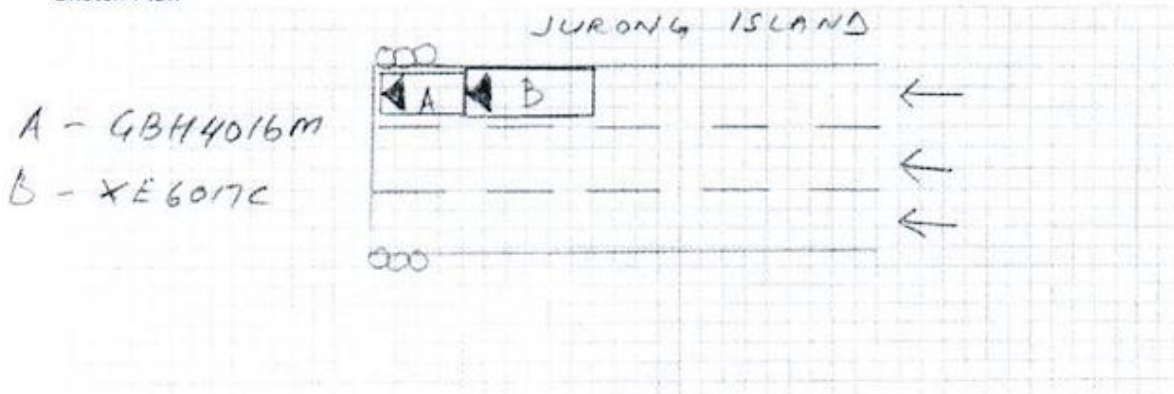
