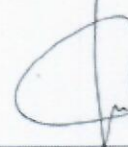

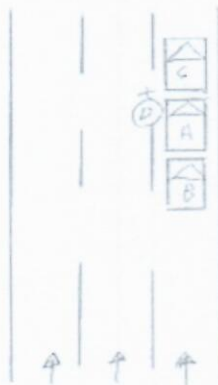

ON THE STATED DATE AND TIME. I, VEHICLE A (SMK7460Y) WAS TRAVELLING STRAIGHT ON LANE 1 OF SLE(CITY) BEFORE UPPER THOMSON ROAD EXIT.
