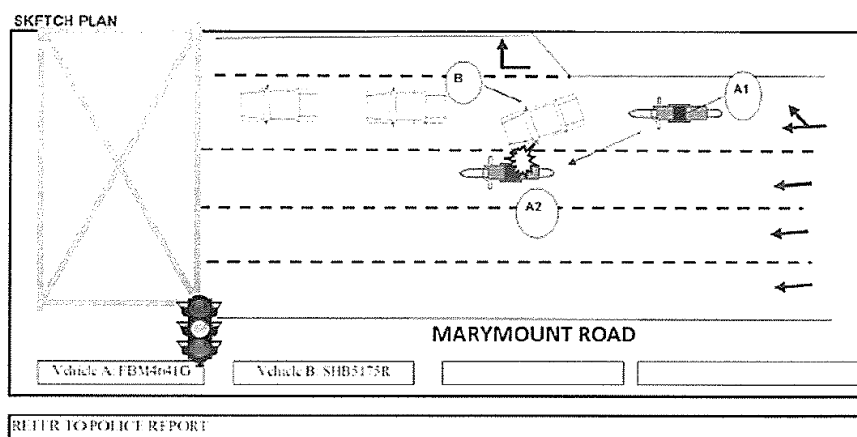

Brief Details.

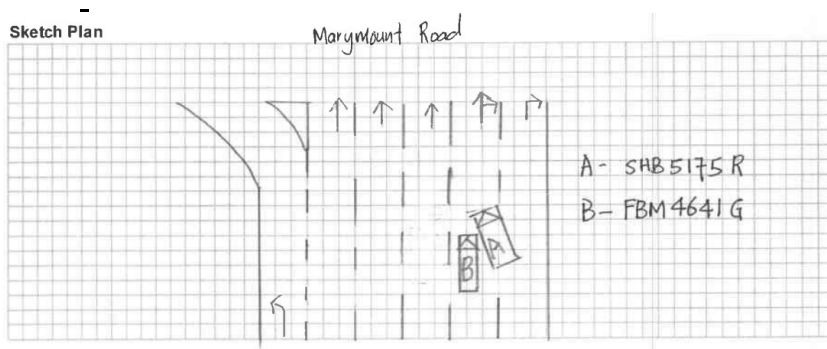
I had lodged a Traffic Report reference T/20211109/7030 on 9/11/2021 at 1602hrs.
