Brief Details.

On 08/05/2022 at about 2100hrs, I was riding my Black color Yamaha R15 bearing JTY3041 along CTE (SLE) near Jalan Bahagia on lane 3. A maroon color SMRT taxi bearing SHB593A which entered my lane from the left to the front of my motorcycle and applied jam brakes suddenly. I was not able to stop on time as such, I hit onto the taxi's rear portion and flung to the lane on my right side. The taxi driver continued driving away and was stopped by other drivers.

I was assisted by other drivers to the side of the road. Shortly, traffic police and ambulance came to scene. I was issued with a case card by the traffic police officer (ref: A/20220508/0140) and advised to lodge a traffic accident report. My motorcycle's left portion and the taxio's rear right bumper suffered some damages. On 09/05/2022 at about 0001hrs, I consulted a doctor at (Central 24hr Clinic Hougang) and was issued with 3 days of MC. I am also lodging this report for insurance purpose.
