

CONTINUATION OF REPORT

Brief Details.

On the 02/04/2022, at 1750hrs, I was driving my vehicle bearing the VRN of SND7191Z on the extreme right lane along the bend of Orchard Turn, Where I noticed another vehicle bearing the VRN SNB3370K traveling on Orchard Link, which managed to filter into Orchard Turn. The said vehicle then formed up directly behind my vehicle. As the traffic was very heavy, my vehicle was stationary as I was waiting for the vehicle in front of me to move off. Subsequently, I felt a light bump on my vehicle and alighted immediately to make a check. I then discovered a deep horizontal scratch and one other minor scratch on my rear driver side area. I then approached the driver of the SNB3370K for his particulars. However, the driver suggested both of us to meet at the carpark area of Takashimaya as both of us were going there. I agreed and left the accident spot without taking any particulars of the driver or any photos of the scene.

I then turned into Takashimaya carpark entrance where I spotted the said vehicle did turned into the entrance as well. However, I did not notice if the said vehicle did entered into the carpark with me as I lost track of him due to the heavy vehicle traffic. I then waited at the carpark entrance and walked around the carpark to look for the said vehicle but to no avail.

I wish to state that I am unsure of the cost of repair and no one was injured from the accident.
