





(B) ADDITIONAL INFORMATION / AMENDMENTS:

I have made a report on the above mentioned accident and would like to include additional information or make the following amendments:

I was driving along AYE towards Tuas before Clementi exit 9. I was about a car and half length away from the front red latio (SJM3002M) when suddenly the front car stopped abruptly where it seemingly did not have any sort of obstruction in front of the car. I immediately applied brake on my car but was not able to stop in time and hit onto the side rear of the front car. Then we stopped the car at the road shoulder to check on the damage. I also check on the driver and she assure that she was not injured. Within 5 minutes while we were talking about accident and exchange of details, a car (SGWW3568E) stopped and 2 Chinese men alighted to offer help in settling the accident and claims. I told them we will settle ourselves however the 2 men only approached and talked the lady. 1 of them say it is dangerous to talk at the expressway and then he went into driver seat of the lady car and both car drive off. After that i attempt to call 2 times a men known as husband answer and say the car is in workshop. (i do have the video footage.)
