



### TERMS & CONDITIONS

#### 1. Payment Terms

The Hirer shall make rental payment to **PERFECT POWER PTE LTD** daily upon signing the agreement. If the payment is not rendered in full, and if total sum of rental sums up to the amount of deposit paid, **PERFECT POWER PTE LTD** will reserve the rights to forfeit the deposit & repossess the vehicle and a repossession fee of \$200 will be charged to the Hirer. Once the vehicle is being repossessed and payment has not been made by the Hirer, **PERFECT POWER PTE LTD** will hand over the case to the legal debt collection department. Cost of \$500 admin charge together with late charge of \$50 and 2% interest per month and 30% of the bad debt owed will be imposed to the Hirer.

#### 2. Breakdown and Towing Services

**PERFECT POWER PTE LTD** will provide an Emergency Breakdown and Towing Service, at no extra cost to the Hirer, in the event the vehicle suffers a breakdown or encounters an accident within Singapore Island. The Hirer agrees that a punctured tire or an empty fuel or any other event resulting in the breakdown of the vehicle due to the Hirer's negligence, the Hirer shall bear the cost of such response at \$100.00 per trip.

#### 3. Damage to the Vehicle

In the event that the vehicle or any part thereof is damaged as a result of any accident howsoever caused, the Hirer shall forthwith pay to **PERFECT POWER PTE LTD**:-

- i. **Insurance Excess amount.** This amount is payable in respect of each and every accident. It must be paid in full before you are able to make an accident report. The Excess amount will be refunded to the Hirer if there has been a successful claim against the third party. The claim is deemed successful if the loss and damage (including any legal fees) is recovered without any deduction for the Hirer's contribution to the accident (if any). The Hirer also agrees that **PERFECT POWER PTE LTD** may in absolute discretion conduct any negotiations with the insurers and agrees to abide by any such settlement.
- ii. **Repair cost** to repair the damages to the rented vehicle at **PERFECT POWER PTE LTD** appointed workshop.
- iii. In the event of **Total Loss/Fire/Theft**, the Hirer agrees to fully compensate the losses incurred by **PERFECT POWER PTE LTD**.
- iv. In the event if the temperature indicator is too high and engine is damaged due to Hirer's negligence, cost of repair shall be bear by the Hirer.
- v. If the car key is being left and locked in the vehicle, the cost of getting a locksmith will be bear by the Hirer.

#### 4. In an event of Accident

Take photographs of the damages and the position of the vehicles at the accident scene.  
Call **PERFECT POWER PTE LTD** immediately to inform about the accident and we will assist you further.  
Failure to obey these procedures may affect the insurance claims process.

#### 5. Duties of Hirer

- i. The Hirer is responsible for all parking and traffic violations which may be incurred and shall answer Police and Traffic court summons. An administrative charge of \$10.00 will be charged upon the Hirer if **PERFECT POWER PTE LTD** is required to pay on behalf of the Hirer.
- ii. The Hirer must return the vehicle in as good order and condition as the one being collected by the Hirer. Failure to do so, the Hirer will have to bear the repair costs of the vehicle.
- iii. **PERFECT POWER PTE LTD** is not liable for any repair or miscellaneous charges incurred at any external workshop.
