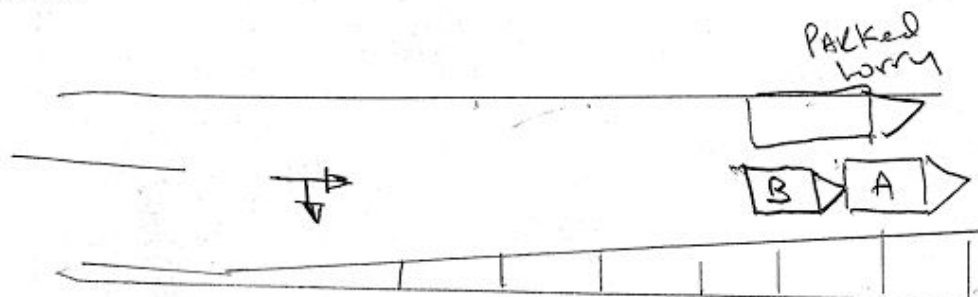
Sketch Plan

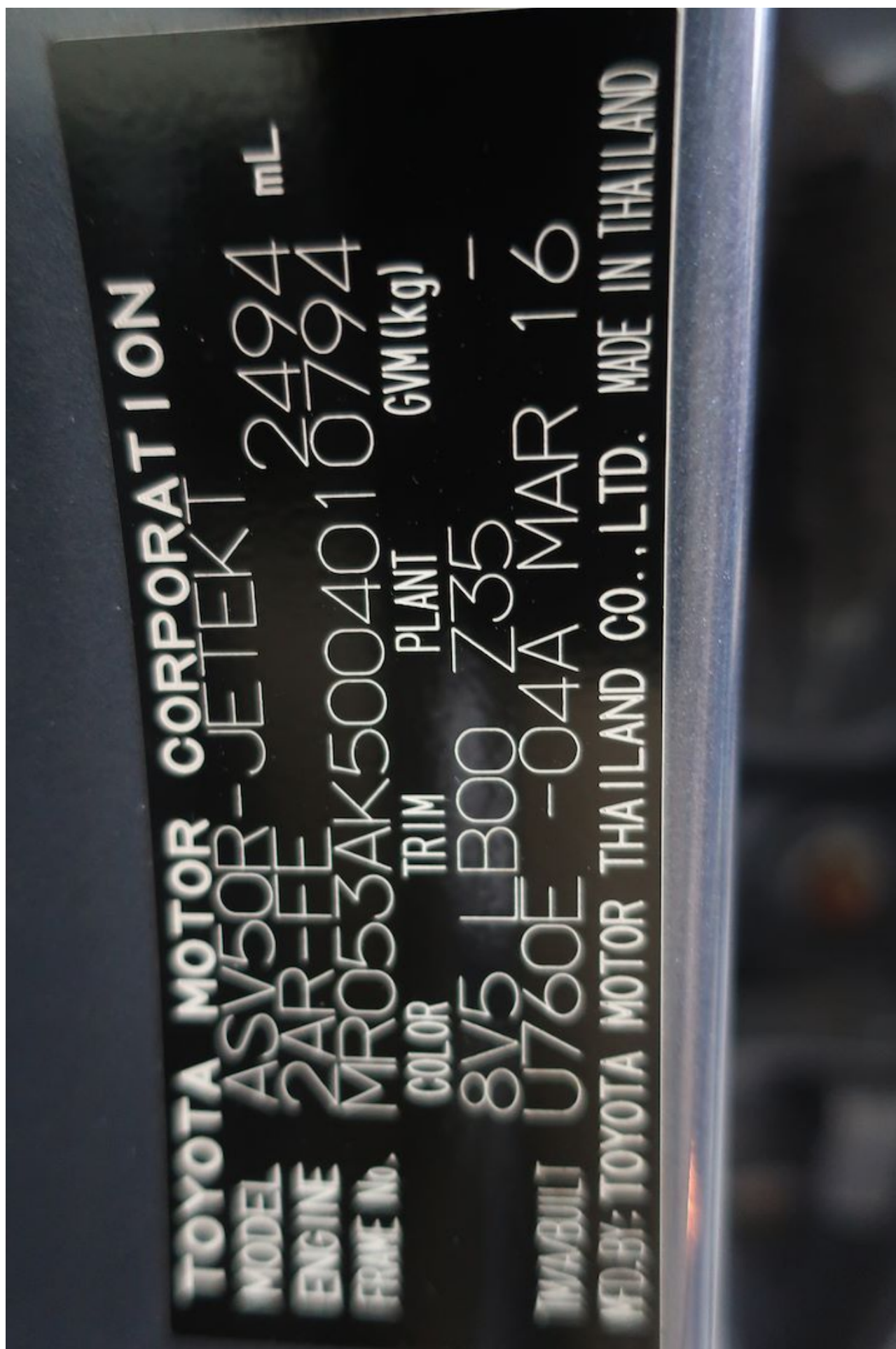


LIMITATIONS AS TO USE
