

- 11.1 Neither party may assign, novate or sub-contract any of its rights or obligations under this Agreement without the prior consent of the other party.
- 11.2 No variation of this Agreement shall be effective unless it is agreed between the parties in writing.
- 11.3 A waiver of any right under this Agreement shall be in writing. Such waiver shall apply only to the person to whom the waiver is addressed and the circumstances for which it is given. Any failure to enforce any provision of this Agreement shall not constitute a waiver of such or any other provision. Unless specifically provided otherwise, rights and remedies arising under this Agreement are cumulative and do not exclude rights and remedies provided by law.
- 11.4 If any provision of this Agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision shall be deemed deleted. Any modification to or deletion of a provision under this clause shall not affect the validity and enforceability of the rest of this Agreement.
- 11.5 This Agreement and any documents referred to in it constitutes the whole agreement between the parties and supersedes all previous arrangements, understandings and agreements between the parties relating to its subject matter.
- 11.6 The parties agree that in the event that any dispute arises out of or in connection with this Agreement, they shall first submit the dispute to Carro for resolution, and shall co-operate with Carro to resolve the dispute within five (5) days. If the parties are unable to reach a mutually satisfactory resolution of the dispute within five (5) days, either party may refer such dispute for settlement by the courts of Singapore.
- 11.7 This Agreement is governed by and will be interpreted in accordance with the laws of Singapore. Each of the parties submits to the exclusive jurisdiction of the Singapore courts as regards any claim or matter arising under this Agreement.
- 11.8 A person who is not a party to this Agreement shall have no right under the Contract (Rights of Third Parties) Act (Chapter 53B) of Singapore to enforce any of its terms.
