We have highlighted to your good office on 17/05/2022 of Third-Party's request to do Direct Settlement with our Principal, Lonpac Insurance Bhd.

The accident occurred when our insured making right turn upon checking 'green arrow light on' & hit onto TP which is travelling straight at the junction.
