

<p>On Sat. 14 May 2022 at about 5.45pm, I was driving along Tiong Bahru Road and had to stop at the traffic light junction as there was a vehicle in front of me waiting to turn right into Redhill Close. As the vehicle was waiting for quite some time at the road junction, I signalled my intention to filter left to turn out. I drove out slowly but a speeding Hyundai vehicle No. SM0 20157 knocked against our front/side of vehicle.</p> <p>The driver, Mrs Christina Yee claimed that she didn't see my indicator signal but the irony is that she could hear at our vehicle just before the impact.</p> <p>The in-vehicle memory card is attached.</p>
