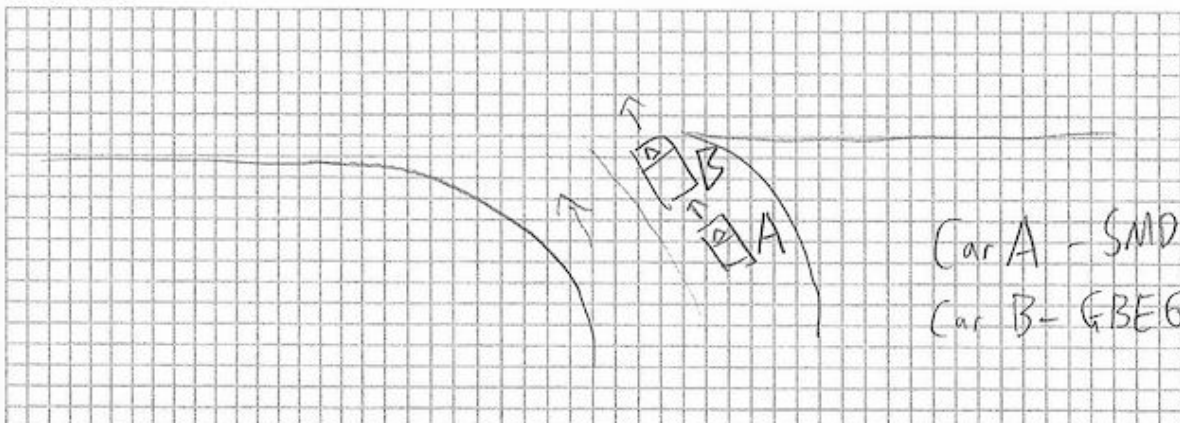

Describe Circumstances of the Accident


At around 4pm on 15 May 2022, I was on the slip road exiting from PIE to Jalan Eunos. I was driving behind a black Nissan Van. We both stopped at the end of the slip road to check for oncoming traffic. When the van moved off, I ~~also~~ turned to my right to check for traffic while starting to accelerate. I did not realize the van had stopped again and was alerted to it by my passenger. I braked but made contact with the rear of the van as he started to move off again. Following the contact, we both stopped at the side of the road to check for damage. I asked the driver to exchange contact information but he said it was unnecessary and told me to just claim insurance.
