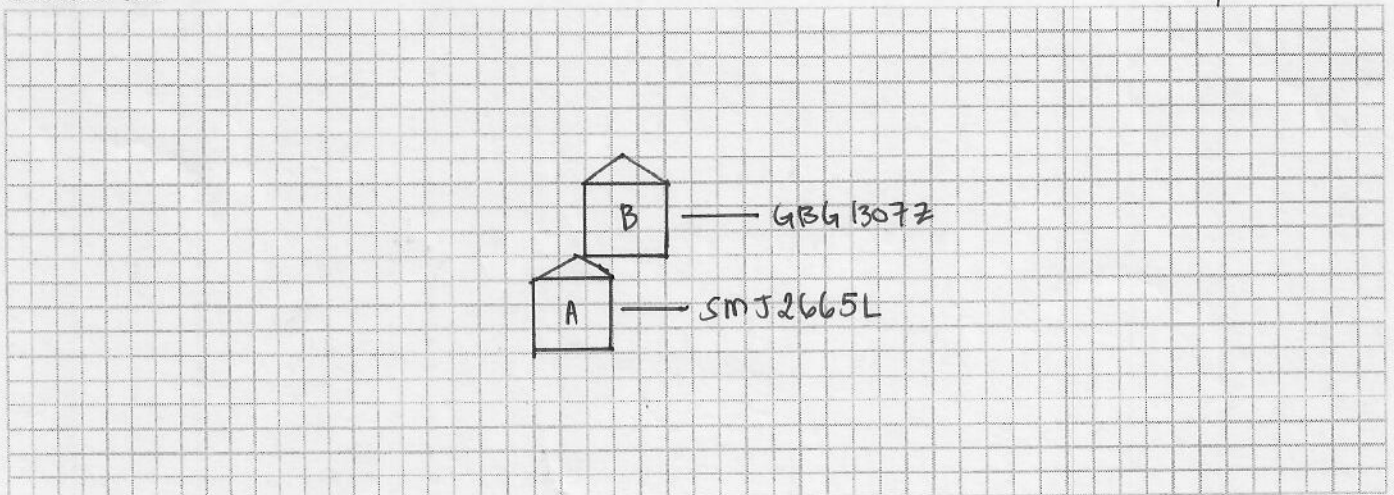

### Sketch Plan




