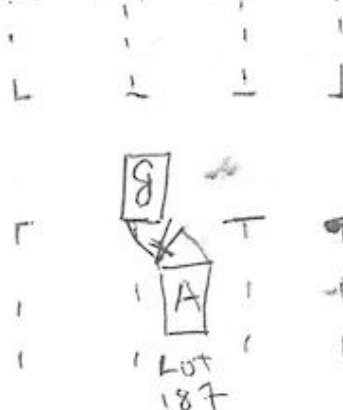
Sketch Plan
