## NOTICE OF IMMEDIATE SUSPENSION UNDER SECTION 47C OF THE ROAD TRAFFIC ACT 1961

We refer to the investigation against you for the possible commission of the offence(s) of Dangerous Driving under Section 64(1) of the Road Traffic Act 1961 punishable under Section 64(2B)(a) of the same Act.

- This is to inform you that in exercise of the powers conferred upon the Deputy Commissioner of Police pursuant to Section 47C of the Road Traffic Act 1961, your driving licence is suspended with effect from 25 May 2022 until such time as the offence for which you have committed is tried and determined by the court, unless sooner rescinded under Section 47C(10) of the Road Traffic Act 1961.
- 3 You are hereby required under Section 47C(4)(b) of the Road Traffic Act 1961 to surrender your driving licence by 10.00 p.m. on 25 May 2022 at Traffic Police, No. 10 Ubi Avenue 3, Singapore 408865.
- 4 Failure to surrender your driving licence under Section 47C(4)(b) of the Road Traffic Act is an offence under Section 47C(5) of the Road Traffic Act 1961.
- 5 During the period of suspension, you shall not drive a motor vehicle on a road under any other driving licence granted by any authority. It is an offence to do so under Section 47C(7) of the Road Traffic Act 1961 and upon conviction, you are liable to a fine not exceeding \$5,000 or to imprisonment for a term not exceeding 2 years or to both and, in the case of a second or subsequent conviction, to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding 4 years or to both.

If you wish to appeal against the suspension, you may write to the Commissioner of Police, Police Headquarters, New Phoenix Park, 28 Irrawaddy Road, Singapore 329560. You should note that notwithstanding your appeal, the suspension of your driving licence takes effect from 25 May 2022.
